CHAPTER 50.

AN ACT to authorize the construction and maintenance of a bridge across the Mississippi river at the city of Winona, Minnesota, and for the acquiring of land for the approaches thereto.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. SECTION 2. Any such corporation, person or May exercise persons, and its and their successors and assigns nent domain. are hereby authorized to acquire by purchase or by exercise of the right of eminent domain, in

the manner prescribed by law for the exercise of such right by railway companies in this state, any lands needed for the construction or maintenance of said bridge or of the approaches thereto.
