CHAPTER 512.

AN ACT to authorize Leander Choate, his associates, heirs and assigns, to build and maintain a dam across Eagle river, in Oneida county, Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Leander Choate, et al., authorized to build dam across Eagle River, Oneida county.

SECTION 1. Leander Choate, W. H. Bradley, Geo. Gerry and Walter Scott, their associates, heirs and assigns, are hereby authorized to build, construct, repair and maintain a flood dam across Eagle river, in section thirty-one, town forty, range ten east, for the purpose of facilitating the running and driving of logs down and out of said Eagle River.

To build suitable slides.

SECTION 2. The said Leander Choate, W. H. Bradley, Geo. Gerry and Walter Scott, their associates, heirs and assigns, shall build suitable slides and gates in said dam for the purpose of sluicing logs through said dam, and shall keep the same in good repair.

May collect tolls.

SECTION 3. When said dam shall have been constructed and made as before provided, the said Leander Choate, W. H. Bradley, Geo. Gerry and Walter Scott, their associates, heirs and assigns, in consideration of the building and operating of said dam, shall be entitled to charge, sue for, and collect tolls on all logs driven down and out of said river by the aid of said dam, not to exceed five cents per thousand feet, board measure; provided, that the tolls hereby authorized to be charged and collected shall be no more than to reasonably compensate said parties for the amount invested and expended in building, maintaining and operating said dam.

Tolls to be a lien, etc.

SECTION 4. The tolls authorized by the provisions of this act, shall be a lien on all logs driven through said dam for the amount thereof at the rate aforesaid, and such lien shall be enforced in the same manner as liens for labor on logs under the general statutes, except as to the time for filing the petition for said lien, which may under

the provisions of this act, be filed at any time within six months after the last of the logs of any mark shall have passed over said slide, or have been driven by the aid of said dam.

SECTION 5. The right to alter, amend or repeal this act is hereby reserved. Reserving right to amend, etc.

SECTION 6. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 513.

AN ACT to appropriate a certain sum to the Wisconsin Veterans' Home.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Whenever the Wisconsin Veterans' Home, an institution duly incorporated pursuant to the laws of this state, under the auspices of the department of Wisconsin Grand Army of the Republic, for the purpose of founding and maintaining a home for destitute honorably discharged Union soldiers, sailors and marines of the late civil war; and the destitute wives and widows who may be residents of this state, shall have been established and put in operation, and such fact shall have been certified by the department commander of the department of Wisconsin Grand Army of the Republic to the governor of this state, the sum of three dollars a week for each inmate of such house shall be paid by the state treasurer to the treasurer of the board of trustees of such home quarterly, upon bills properly certified under oath by the president and secretary of such board of trustees, stating the names of the inmates for whose maintenance therein compensation shall be claimed, and the length of time during the quarter each of such persons shall have been maintained therein; provided, that no money shall be paid from the state treasury for the maintenance
