AN ACT to amend chapter 27, laws of 1889, entitled, "An act to revise consolidate and amend chapter 127, laws of 1837," entitled, "An act to incorporate the city of Ashland."

### The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 2 of chapter 2 of chapter Amends chap-127, of the laws of 1887, is hereby amended so as of 1887. Ward to read as follows: Section 2.
