

the action, and their rights adjudicated therein. Such bonds shall be equal liens upon the property for the assessments represented by such bonds without priority one over another, to the extent of the several assessments against the lots and parcels of land against which the special assessments shall have been made. Upon the commencement of any such action, the plaintiff shall cause a notice thereof to be filed in the offices of the county clerk and county treasurer, designating the particular property affected by such foreclosure and thereafter no redemption of any such property from such assessments shall be had, without payment of all costs theretofore accrued in such action, except as hereinbefore provided.

CHAPTER 263.

AN ACT to provide for the annual appropriation of a sum of money therein named to the Wisconsin Cranberry Growers' Association.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is hereby annually appropriated to the Wisconsin Cranberry Growers' Association, the sum of two hundred and fifty dollars.

SECTION 2. Said moneys shall be used exclusively for the purposes of procuring and publishing information relative to the cultivation and production of cranberries.

SECTION 3. Said society shall hold two meetings annually, one in the month of August, and one in January, of each year, at such place as shall be previously fixed by a vote of the society.

SECTION 4. The secretary of the society shall report to the governor annually, immediately after the January meeting, an itemized account, duly verified, of all disbursements made during the previous year, and shall therewith publish in pamphlet form a pamphlet of not to exceed fifty pages, which shall contain an account of the transactions of the association, and a compilation of the best information which it shall have been able to collect during the previous year, relative to the cultivation and production of cranberries, and shall cause two hundred and fifty copies thereof to be distributed gratuitously to cranberry growers in the state of Wisconsin.

SECTION 5. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 264.

AN ACT to authorize the parties therein named to construct and maintain a dam across Clam river in township thirty-eight north, of range fourteen west, and to collect tolls on the same.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. John Arbuckle, his heirs and assigns, are hereby authorized to erect, maintain and keep up a dam across the Clam river, at a point on the northeast quarter of section thirty, of township thirty-eight north, of range fourteen west, in Burnett county; provided that such dam shall not raise the water to exceed ten feet; provided, said John Arbuckle shall be the owner of the land upon which said dam is hereby authorized to be erected, or shall acquire title to the same within one year from the date of the passage of this act.
