SECTION 6. Any person, firm or corporation Fishways to be owning, occupying or having charge of any dam March 1st to or dams in this state, wao shall fail to keep the fishways in such dam or dams open and unobstructed during the time between the first day of March and the succeeding fifteenth day of June in each year, shall be liable upon conviction thereof, to a fine of not less than ten dollars per day for each and every day such fishway shall not be open and unobstructed during the time specified.

SECTION 7. One-half of the fines imposed by Fines, how divided. this act shall go to the person or persons upon whose information the charge was made upon which a conviction was secured under the provisions of this act.

SECTION 8. All acts or parts of acts incon- Repeal. sistent with or conflicting with this act are hereby repealed.

SECTION 9. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 338.

AN ACT to allow Forest county and certain towns therein to raise and expend moneys for county and school purposes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. In addition to the moneys here forest county authorized and allowed to be raised, the raised, the raised to raise \$1,500 annually, for county of Forest is hereby authorized and allowed to be raised, the raise \$1,500 annually, for county purposes lowed to raise and expend the sum of fifteen poses. hundred dollars annually, for county purposes.

Towns of Cran don and Gagen authorized to raise \$350 annually for school purposes.

SECTION 2. In addition to the moneys heretofore authorized and allowed to be raised in the towns of Crandon and Gagen, in the county of Forest, are hereby authorized to raise and expend in each of said towns the sum of two hundred and fifty dollars annually hereafter, for school purposes.

CHAPTER 339.

AN ACT to amend sections 2 and 3, of chapter 526, laws of 1889, and section 5, of chapter 249, laws of 1891, entitled, "An act to provide for and regulate the printing, binding and distribution of the reports of state officers, departments, institutions and societies."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Amending chapter 526, laws of 1891, and chapter 249, laws of 1891,

SECTION 1. Section 2, of chapter 526, of the laws of 1889, is hereby amended by striking out the word "three" where it occurs in the seventh line of the same section and insert in lieu thereof the word "five;" strike out the words "the report of the insurance commissioner, one hundred pages," where they occur in lines 12, 13 and 14 of section 2, by substituting for the words "supervisors, two hundred" in the fifteenth line, the words "control, three hundred and fifty;" and by eliminating the words, "the report of the state board of charities and reform. one hundred and fifty pages," in the sixteenth and seventeenth lines, so said section shall read as follows: Section 2. The biennial reports
