- AN ACT to amend subsection 1, of section 4725a, of the statutes, relating to the suspension of sentence under supervision of minors.
- The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1, of section 4725a, of the statutes, is amended to read: (Section 4725a) 1. If any minor • • • be found guilty of any misdemeanor, or be convicted of a felony for the first time, for which offense the maximum penalty shall not exceed seven (7) years, the court in its discretion, may suspend sentence and place such minor under the guidance and control of some reputable and suitable adult person, who shall have consented in writing to become responsible for the good behavior of such minor, for such period of probation not exceeding six months as the court may fix.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 132.

AN ACT to amend subsection 1 of section 450—1 of the statutes, relating to the examination, qualification, and certification of teachers.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1 of section 450—1 of the statutes is amended to read: (Section 450—1.) 1. Every applicant for a third grade certificate shall be examined in orthoepy, spelling, reading, penmanship, arithmetic, elementary composition and grammar, geography, the history of the United States, the civil government of the United States and of the State of Wisconsin, physiology and hygiene with special reference to the effects of stimulants and narcotics upon the human system, school management, the manual of the elementary course of study for the common schools of Wisconsin, and the elements of agriculture, and in addition to passing examinations in the aforesaid branches, he shall have attended a professional school for teachers for at least six weeks and shall have received in such school standings in school management, and in the methods of teaching reading and language, arithmetic and geography, provided.

however, that the provisions of this section relative to attendance at professional schools for teachers shall not apply to persons who have taught successfully in the public schools for at least eight months prior to July 1, 1910, nor to graduates from free high school teachers' training courses which had been especially approved by the state superintendent prior to July 1, 1910, nor to graduates from teachers' training courses equivalent thereto, which, since July 1, 1910, have been, or which in the future may be, adopted by any high school board, or board of education, and approved by the state superintendent, and provided further, that the provisions of this section relative to attendance at professional schools for teachers shall not apply to persons in counties in which no professional schools for teachers are situated, if the county superintendent of any such county shall approve of the reasons advanced by any such person for non-attendance at any such professional schools for teachers.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 133.

AN ACT to create section 376-8 of the statutes, relating to memorial hall, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 376-8. 1. There shall be appropriated annually for the use of the custodian of the Soldiers' and Sailors' Memorial Hall the sum of one hundred and fifty dollars, which money shall be used by him for the purchase and rebinding of books, the purchase and framing of pictures, the procuring of war relics, and for such other purposes as shall, in the judgment of the said custodian, best answer the purpose for which the said hall is established.

2. The money thus appropriated shall be paid out of the state treasury upon vouchers certified by the custodian and approved by the governor.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
