CHAPTER 72.

AN ACT to amend subsection 1 of section 710 of the statutes, relating to the bond of the county treasurer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection 1 of section 710 of the statutes is amended to read: (Section 710) 1. The bond of the county treasurer shall be in a sum to be fixed at not less than twice the amount of all taxes directed by the county board to be levied and received by the treasurer during the ensuing year and have three or more sureties, except said bond be furnished by a surety company, in which case the amount thereof shall be fixed at not less than the amount directed, by the county board, and to be conditioned in substance as follows: Whereas, the above bounden was elected to the office of county treasurer of the county of on the day of now, therefore, the condition of the above obligation is such, that if the said and his deputy, and all persons employed in his office shall faithfully execute the duties of said office, and if the said shall pay according to law all money that shall come to his hands as treasurer, including all drainage funds, and shall render a just and true account thereof whenever required by the county board or by any provision of law, and shall deliver to his successor in office or to any other person authorized by law to receive the same, all moneys, books, papers and other things appertaining or belonging to said office, then the above obligation shall be void; otherwise to be and remain in full force.

Section 2. This act shall take effect and be in force upon its passage and publication.

CHAPTER 73.

AN ACT to amend sections 1498a and 1498d of the statutes, relating to fish and game wardens.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Sections 1498a and 1498d of the statutes are amended to read: Section 1498a. The state game warden shall appoint sixty deputy game wardens; he shall appoint one from each senatorial district in the state and the others from the state at

large to be distributed in such manner as to promote the best interests of the service. Each such deputy warden shall be selected from a list of eligibles furnished by the state civil service commission, and to that end a separate list of eligibles shall be prepared for each senatorial district. Such deputies when appointed shall hold office during good behavior, and shall in all respects be subject to the provisions of the civil service law. The state game warden may assign work to any deputy warden anywhere within the boundaries of the state, and, may, upon request direct any such warden to do educational work, pertaining to fish and game, by lecturing in schools, at farmers' institutes or at other meetings held for educational purposes. The state game warden may. from time to time as the needs of the service require and the condition of the fund will permit, appoint additional special deputy wardens for temporary or occasional service from an eligible list selected from the state at large. Nothing in this section shall be deemed to affect the tenure or eligibility of persons now in the service.

The deputy wardens appointed as provided in Section 1498d. section 1498a, shall each receive a per diem to be fixed by the state warden, by and with the approval of the governor, which per diem shall include pay for such days as each deputy shall be under the direct order of the state warden to perform services in the enforcement of the fish and game laws, or engaged in educational work, as provided in section 1498a of the statutes, and upon certificate of said warden that such services have been actually rendered at his instance and under his direction. In addition to the per diem provided for, such deputies shall receive their actual necessary expenses incurred while working under the direction of the state warden, which expenses shall be paid upon vouchers therefor countersigned by said state fish and game war-The said office force from and after February 1, 1911, shall consist of one bookkeeper at a salary not exceeding twelve hundred dollars per year; one clerk at a salary not exceeding nine hundred dollars per year; and one stenographer at a salary not exceeding nine hundred dollars per year, and temporary services of help required from time to time to carry out the provisions of law. Such appointments to be made by state fish and game warden.
