CHAPTER 293.

AN ACT to amend subsection 5 of section 172—54 of the statutes, relating to teachers' institutes and reading circles, and making an appropriation therefor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 5 of section 172—54 of the statutes is amended to read: (Section 172—54). 5. There is annually appropriated on July first, nine thousand five hundred dollars, payable from any moneys in the normal fund income not otherwise appropriated, to the board of normal regents for institutes for the instruction of teachers as provided for in section 407 and for summer schools for teachers, *and for expenses connected with the conducting of a state teachers' and a state young people's reading circle organized by the Wisconsin Teachers' Association, provided, that not to exceed one-tenth of the sum appropriated in this section shall be allowed for such reading circle purposes in any one school year, and provided, further, that such expenditures for reading circle purposes shall, before being allowed, be approved by the state superintendent of public instruction.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 294.

AN ACT to amend subsection 1 of section 4560f—10, of the statutes, relating to the taking of rough fish by means of nets.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1 of section 4560f—10 of the statutes is amended to read: (Section 4560f—10) 1. The state fish and game warden is hereby authorized to take, or cause to be

taken, by means of nets from any of the inland waters in this state, exclusive of the * * * Rock river in Dodge county and Lake Koshkonong, buffalo fish, carp, dogfish, garfish, eel-pout, red horse, sheepshead or suckers whenever he shall find that such fish or any of them are detrimental to and tend to retard the propagation of or destroy game fish therein.

CHAPTER 295.

AN ACT to create subdivision 5 of section 4560a—46 of the statutes, relating to the use of nets and traps in outlying waters.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to section 4560a—46 a new subdivision to read: (Section 4560a—46) (5). The waters of Mud Bay in the town of Bailey's Harbor, Door county.

CHAPTER 296.

AN ACT to create section 4595da of the statutes, relating to works of necessity or charity.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is added to the statutes a new section to read: Section 4595da. The keeping open of a store or shop in cities of the first class, for the sale of groceries, meats or meat products, on the first day of the week, shall not be deemed a work of necessity or charity.

SECTION 2. This act shall take effect on November 1st, 1915.
