CHAPTER 486.

AN ACT to amend subdivision (a) of subsection 2 of section 1636—241; to renumber section 172—124 to be subsection 1 of said section; and to create subsection 64 of section 170 and subsection 2 of section 172—124 of the statutes, relating to the state athletic commission and making an appropriation from moneys turned into the state treasury by said commission.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subdivision (a) of subsection 2 of section 1636—241 of the statutes, is amended to read: (Section 1636—241. 2.) (a) The commission shall appoint, and may remove, a secretary to the commission, whose duty it shall be to keep a full and true record of all the proceedings, of the commission, preserve at its general office all its books, documents and papers, prepare for service such notices and other papers as may be required of him by the commission, and to perform such other duties as the commission may prescribe; and he may, under the direction of the commission, issue subpoenas for the attendance of witnesses before the commission with the same effect as if they were issued in an action in the circuit court, and may, under the direction of the commission, administer oaths, in all matters appertaining to the duty of his office or connected with the administration of the affairs of the commission. Disobedience of such subpoenas and false swearing before such secretary, shall be attended by the same consequences, and be subject to the same penalties, as if such disobedience or false swearing occurred in an action in the circuit court. * * *

SECTION 2. Section 172—124 of the statutes is renumbered to be subsection 1 of section 172—124.

SECTION 3. There is added to section 170 and to section 172—124 of the statutes, a new subsection in each case to be numbered and to read: (Section 170) 64. The secretary of the state athletic commission shall receive such salary as the commission shall fix, not exceeding fifteen hundred dollars per annum. Each member of the said commission shall receive a compensation of five dollars per day for each day actually spent in the performance of his official duties, but the total per diem of all members shall not exceed fifteen hundred dollars per annum. The commission shall fix the salary or compensation of its employes. The members of the commission, the secretary and employes shall receive actual and necessary traveling expenses

incurred in the discharge of their official duties. All salaries, compensations and expenses provided for in this subsection shall be charged to either of the appropriations for the state athletic commission.

(Section 172—124) 2. Moneys paid into the state treasury by the state athletic commission to an amount not exceeding fifteen hundred dollars per annum, are appropriated for the said commission to pay salaries and expenses of the commission.

SECTION 4. This act shall take effect as of July 1, 1915.

CHAPTER 487.

AN ACT to renumber section 925—175 to be subsection 1 of section 925—175, and to create subsection 2 of said section 925—175, relating to the opening, paving and grading of streets, alleys and courts.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 925—175 of the statutes is renumbered to be subsection 1 of section 925—175.

SECTION 2. There is added to section 925—175 of the statutes a new subsection to read: (Section 925—175) 2. In cities of the third and fourth classes when the expense of macadamizing, paving or repaving any street, alley or court is to be assessed in whole or in part against the abutting property, the owners of more than one-half of the frontage of the lots upon the part of the street, alley or court proposed to be macadamized, paved or repaved, may, at any time within fifteen days after the council determines, as provided in subsection 1 of this section, to macadamize, pave or repave such street, alley or court, petition the council in writing requesting that said part of said street, alley or court be macadamized, paved or repaved with certain material and the council shall let the contract for the macadamizing, paving or repaving of said street, alley or court with the kind of pavement requested and set forth in said petition.

SECTION 3. This act shall take effect upon passage and publication.
