CHAPTER 523.

AN ACT making an appropriation to defray expenses of the committee appointed pursuant to resolution No. 27, A.

Whereas, The committee heretofore appointed pursuant to resolution No. 27, A. to ascertain the facts relative to the matter of creating the county of Burke from territory to be detached from Shawano and Outagamie counties has completed its work and made report as required, and has, pursuant to the duties imposed and authority conferred by said resolution, incurred expenses in traveling to and from the said counties of Shawano and Outagamie and for a stenographic reporter, for the payment of which no appropriation has been made.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated out of any money in the treasury not otherwise appropriated the sum of twenty-one dollars to G. M. Byse; twenty-four dollars and twenty cents to E. A. Everett; twenty-six dollars and thirty-four cents to J. J. G. Laing to reimburse them as members of the committee appointed pursuant to resolution No. 27, A. for expenses incurred, and one hundred eighty-one dollars and fifty-two cents to Andrew Snyder for services rendered and expenses incurred by him as stenographic reporter for said committee.

CHAPTER 524.

AN ACT to appropriate to the state board of agriculture a sum of money therein named to defray the indebtedness of said board.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated out of any money in the treasury not otherwise appropriated the sum of thirty-five thousand dollars to defray all the indebtedness of the state board of

agriculture incurred prior to April 1, 1915. Any part of said amount unexpended for such purpose shall revert to the general fund.

CHAPTER 525.

AN ACT to repeal subsections 3, 4, and 5, and to amend subsections 1, 2, 6 and 7 of section 2339m of the statutes, relating to marriage and venereal diseases.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsections 3, 4 and 5 of section 2339m of the statutes are hereby repealed.

SECTION 2. Subsections 1, 2, 6 and 7 of section 2339m of the statutes are amended to read: (Section 2339m) 1. All male persons making application for license to marry shall at any time within fifteen days prior to such application, be examined as to the existence or nonexistence in such person of any venereal disease, and it shall be unlawful for the county clerk of any county to issue a license to marry to any person who fails to present and file with such county clerk a certificate setting forth that such person is free from * * * venereal diseases so nearly as can be determined by a thorough * * * examination and by the application of the recognized clinical and laboratory tests of scientific search, *when in the discretion of the examining physician such clinical and laboratory tests are necessary. When a microscopical examination for gonococci is required such examination shall upon the request of any physician in the state be made by the State Laboratory of Hygiene free of charge. The Wasserman test for syphilis when required shall upon application be made by the psychiatric institute at Mendota free of charge.* Such certificate shall be made by a licensed physician, shall be filed with the application for license to marry, and shall read as follows, to wit:

I, (Name of Physician), being a legally licensed physician, do certify that I have this day of, 19. . . , * * * made a thorough examination of (Name of Person), * * * and * * * believe him to be free from all venereal diseases. * * *

. (Signature of Physician.)
