read: Section 1410b—10. 1. Special dairy and food inspectors may be appointed by the dairy and food commissioner for any factory or plant which buys or receives milk or cream to be manufactured into butter or cheese, or to be condensed, or to be sold as market milk or cream, or for a group of such factories or plants or for any organization organized for the purpose of selling butter or cheese upon petition therefor signed by more than two-thirds of the regular patrons of such factory or plant, or by the officers of the organization representing such group of factories or plants, and upon receiving satisfactory proof that such special dairy and food inspectors will be compensated in full for all services rendered and traveling expenses incurred upon and pursuant to such appointment by such patrons making such petition. The state shall not be liable for any such compensation.

2. Each such special dairy and food inspector shall have all powers conferred by law upon dairy and food inspectors and shall at all times be under the supervision of the dairy and food commissioner and he shall make such reports to the dairy and food commissioner as the said commissioner may require. He shall supervise and inspect the weighing and testing of and shall inspect all milk or cream or butter or cheese delivered to such factory or plant, or group of factories or plants, and for such purpose may use any or all weighing or testing apparatus in such factory or plant. In addition to the duties herein specifically prescribed he shall perform such duties as the patrons or organizations compensating him or the dairy and food commissioner may direct.

Section 2. This act shall take effect upon passage and publication.

## CHAPTER 363

AN ACT to create subsection 8 of section 1492em of the statutes, relating to tagging of cattle tested for tuberculosis.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. There is added to the statutes a new subsection to be numbered and to read: (1492em) 8. The department of agriculture shall provide ear tags to be used for tagging cattle tested for tuberculosis and shall distribute the same to persons authorized by the department to test cattle. Such distribution

shall be made at a price sufficient to cover the cost of the tags and their distribution.

Section 2. This act shall take effect upon passage and publication.

## CHAPTER 364

AN ACT to create subsection (20) of section 670 of the statutes, relating to special powers of county boards.

A new subsection is added to the statutes to read: (Section 670) (20) To discontinue, at the option of the county board, any county school of agriculture and domestic science, and the maintenance thereof, created and maintained by such county under sections 553c to 553l, inclusive; and to devote, use or permit to be used, any lands, buildings, equipment and property that may have been purchased or used by such county school of agriculture and domestic science, for any other institution that may be maintained by the county, or use the same for such other public purpose permitted by law to counties as, in the discretion of the county board, shall be for the best interests of the public.

## CHAPTER 365

AN ACT to create subsection 18 of section 1958 of the statutes, relating to the insurance which may be effected by fraternal benefit societies.

Section 1. A new subsection is added to section 1958 of the statutes to read: (Section 1958) 18. (a) Any fraternal benefit society authorized to do business in this state, and operating on the lodge plan, may provide in its constitution and by-laws, in addition to other benefits provided for therein, for the payment of death or annuity benefits upon the lives of children between the ages of two and eighteen years at next birthday, for whose support and maintenance a member of such society is respon-
