meet allotments made by the United States; said sum to be levied and collected as provided by law, as a state tax levy, in addition to any other state tax levies provided by law, providing that no part of this appropriation shall be available until the state treasurer has actually received moneys collected hereunder in such amount.

SECTION 2. This act shall take effect upon July 1, 1919. Approved July 23, 1919.

CHAPTER 633.

AN ACT to grant to the City of Kenosha certain submerged lands lying along the shore of Lake Michigan on the eastern frontage of the City of Kenosha.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. All right, title and interest of the State of Wisconsin in and to the lands now and heretofore submerged beneath the waters of Lake Michigan and described as follows: Commencing at the southeast corner of section Thirty (30). Town two (2) North Range Twenty-three (23) east of the Fourth (4) P. M., the same being the intersection of the center line of Broad St., and the center line of Washington St., thence north thirty-three (33) feet along the section line to the north line of Broad St.; thence northwesterly in a straight line to a point on the south line of Hanson St. which is 410.8 ft. east of the east line of Lake Ave., thence continuing northwesterly in a straight line to a point on the north line of Hanson St. which is 399.7 ft. east of the east line of Lake Ave; thence continuing northwesterly in a straight line to a point on the south line of Bronson St. which is 357.3 ft. east of the east line of Lake Ave.; thence continuing northwesterly in a straight line to a point on the north line of Bronson St., which is 344 ft. east of the east line of Lake Ave., thence continuing northwesterly in a straight line to a point on the south line of Division St. which is 200 ft. east of the east line of Lake Ave.: thence west 200 ft. along the south line of Division St. to the east line of Lake Ave.: thence north 1376.1 ft. to the north line of the southeast quarter of section 30; thence east 355 ft. along the said quarter section line extended out into Lake Michigan: thence right 80° 48' and running in a southeasterly direction parallel with the general shore line of Lake Michigan to a point in Lake Michigan on the south line of fractional section 29 and the center line of Broad St. extended east which point is 329 ft. east

of the southwest corner of said fractional section 29; thence west 329 ft. to the point of beginning. Containing 24.4 acres more or less. All the premises hereinbefore described lying and being in the southwest fractional quarter of section 29, and the southeast fractional quarter of section 30, Town 2 North Range 23 east of the 4th P. M., in the county of Kenosha and state of Wisconsin, said premises conveyed to the City of Kenosha to be used for public park purposes.

Section 2. Upon the passage and publication of this act, the commissioners of public land of the State of Wisconsin are hereby authorized, empowered and directed to and shall execute to the City of Kenosha, patents for the submerged lands herein granted and ceded to the City of Kenosha.

Section 3. This act shall take effect upon passage and publication.

CHAPTER 634.

AN ACT to amend section 1172 of the statutes, relating to publication of notice of the time for redemption of lands sold for taxes.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact of follows:

Section 1. Section 1172 of the statutes is amended to read: Section 1172. Whenever, by mistake or otherwise, such treasurer neglects or fails to include in his published list any such tract or tracts of land or to publish such list in accordance with the requirements of law, the same may be published at any time within * * * two * * * years after the expiration of said three years; such publication shall be made in the same manner and for the same time as prescribed in the preceding section, and such treasurer shall specify in his notice accompany. ing such published list when the time for making redemption of such lands from such sale will expire, which time shall not be less than six nor more than ten months from the expiration of the full twelve weeks required for the aforesaid publication; and all deeds made * * upon such tracts of land after the expiration of said three years, shall after the expiration of such extended period of redemption, be as valid and effectual as if such publication had been made at the time required in such section.

SECTION 2. This act shall take effect upon passage and publication.
