dollar, four per cent government bond for each month's service or major fractional part thereof in such war; and

WHEREAS, Such provision should be a substantial recognition of such services and sacrifices and would be greater than this state or any other state contemplates as compensation therefor. Now, therefore, be it

Resolved by the Assembly, the Senate concurring, That the congress of the United States be respectfully urged to enact such bill into law at the earliest possible time and that each United States senator and representative in congress from this state be earnestly requested to use his best efforts to secure the early passage of such measure. And be it further

*Resolved*, That a suitable copy of this resolution properly attested be transmitted to the presiding officers of each house of the congress and to each United States senator and representative from this state.

## [Jt. Res. No. 112, S.] JOINT RESOLUTION NO. 88.

Urging congress to continue the work of vocational rehabilitation among our wounded and disabled soldiers, sailors and marines.

WHEREAS, By a rider to H. R. 6176 known as the Sundry Civil Appropriations Bill, the work of vocational rehabilitation among the soldiers, sailors and marines who were wounded in the world war will be seriously hampered, if not destroyed; and

WHEREAS, The force of the Federal board of vocational education has after a training period of five months reached such a point of efficiency that it can now serve these soldiers, sailors and marines intelligently and adequately according to their needs, and particularly with reference to their disabilities; and

WHEREAS, There are now forty-six thousand wounded and otherwise disabled soldiers, sailors and marines in the United States who have not yet been reached by the Federal board of vocational education, and there are many more in France; and

WHEREAS, The force of the Federal board of vocational education in the camps and hospitals of the country has been called in because of the impending lack of funds; and

WHEREAS, The nation in a special manner owes these injured and disabled soldiers, sailors and marines, as a matter of right and justice, every effort to remedy their disabilities and to promote their physical well being and vocational rehabilitation. Therefore, be it Resolved by the Senate, the Assembly concurring, That we urge the congress of the United States to reconsider and defeat the rider to the sundry civil appropriations bill because it would seriously hamper the work of the vocational rehabilitation by the Federal board of vocational education among the wounded and disabled soldiers, sailors and marines. Be it further

*Resolved*, That a copy of the substance of this resolution be wired to the presiding officers of both houses of congress, to the senators and congressmen of this state, and that complete copies of this resolution signed by the presiding officers of each house, be forwarded to the senators and congressmen from this state.

To His Excellency, The President of the United States:

WHEREAS, Because of such vacancy an appointment will necessarily have to be made to fill such vacancy; now therefore be it

Resolved by the Senate and the Assembly of the State of Wisconsin, That, because of the familiarity of the Honorable A. H. Wilkinson with all boundary questions that may arise between the United States and Canada, and high qualifications to perform the duties of the office, respectfully recommend that the said Honorable A. H. Wilkinson be made a member of the International Boundary Commission. And be it

Resolved further, That a copy of this endorsement be properly engrossed and attested by the presiding officers and clerks of each house, and a copy of the same be transmitted to the President of the United States.
