CHAPTER 360.

AN ACT to transfer a certain sum of money from the soldiers' rehabilitation fund to the university fund income and to authorize the board of regents to pay the amount of the appropriation to the Immel construction company.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is transferred from the soldiers' rehabilitation fund to the university fund income the sum of fourteen thousand seven hundred ninety dollars and thirty-four cents to be credited to the appropriation authorized by paragraph (c) of subsection (10) of section 20.41 of the statutes.

SECTION 2. The board of regents of the university are directed and empowered to pay from said appropriation made by paragraph (c) of subsection (10) of section 20.41 of the statutes fourteen thousand seven hundred ninety dollars and thirty-four cents to the Immel construction company.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 361.

AN ACT to repeal subsection (3) of section 20.51 of the statutes, relating to an appropriation to the railroad commission for the purchase of Wisconsin railroad maps; and to amend subsection (1) of section 20.51 of the statutes relating to the railroad commission, and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (3) of section 20.51 of the statutes is repealed.

SECTION 2. Subsection (1) of section 20.51 of the statutes is amended to read: (20.51) (1) Annually, beginning July 1, * * * 1925, one hundred eighty * * * thousand dol-

lars, for administration and the execution of its general functions. Of this there is allotted to each member of said commission an annual salary of five thousand dollars.

SECTION 3. This act shall take effect July 1, 1925.

CHAPTER 362.

AN ACT to appropriate a sum of money named therein from the soldiers' rehabilitation fund to the city of Cudahy, Wisconsin, as refund for overpayment of taxes to the state.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated from the soldiers' rehabilitation fund the sum of one thousand eight hundred and three dollars and sixty-seven cents to the city of Cudahy, Wisconsin, to reimburse said city for a refund made by it to the Cudahy Brothers Company for an overpayment of soldiers' bonus and soldiers' educational bonus surtaxes made by said company on its income for the year 1918.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 363.

AN ACT to amend subsection (1) of section 20.10 of the statutes, relating to wages of charwomen employed in the state capitol building and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 20.10 of the statutes is amended to read: (20.10) (1) Annually, beginning July 1, 1923, one hundred fifty-two thousand dollars, for the general administration expenses of his office, and the cost of furnishing
