was located at the time of the fire, on five days' notice in writing, to be given by either party to the other, of his, her, or its intention so to do. Any such notice in writing, when served by the insured must be served as provided in subsection (9) of section 262.09 of the statutes; and the said judge shall, on proof by affidavit of the failure or neglect of said appraisers to agree upon or select an umpire within the time provided in said policy, and of the service of notice aforesaid, forthwith appoint a competent and disinterested person to act as such umpire in the ascertainment of the amount of said loss or damage.

SECTION 2. The provisions of this act requiring notice before appointment of an umpire shall not be interpreted as a legislative declaration that no such notice is necessary under the present law.

Section 3. This act shall take effect upon passage and publication.

CHAPTER 268.

AN ACT to amend section 192.07 of the statutes, relating to conditions as to carrying live stock.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Section 192.07 of the statutes is amended to read: 192.07 Every corporation operating a railroad in this state shall receive any and all live stock offered to it or to any of its agents or employes * * for transportation, in mixed carloads containing different kinds of live stock, and shall make and deliver to the shipper or consignor the usual bill of lading or live stock contract for the same * * Such corporation shall furnish for mixed cars of live stock suitable partitions, subject to the approval of the railroad commission, upon such terms and conditions as shall be ordered by the commission after public hearing. In case the partition or partitions shall become loose or broken so as to allow such live stock to become * * mingled in the car during the course of transportation the corporation so transporting the same shall * * * as soon as practicable repair and replace the partition or partitions before said car shall be

further transported * * * . Said company transporting such cars of live stock shall feed and water, at its own expense, such stock as shall be so unloaded where such stock shall be detained for a longer period than six hours. The corporation transporting such live stock may charge therefor the current rate for the transportation of the highest class of live stock so shipped in each mixed car. It shall be unlawful for any shipper or railroad corporation to load live stock in mixed carloads unless the stock is separated as hereinbefore provided.

Section 2. This act shall take effect upon passage and publication.

CHAPTER 269.

AN ACT to amend subsection (2) of section 5.12, subsection (4) of section 6.22 and section 331.25 of the statutes, relating to publication fees of election notices.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (2) of section 5.12, subsection (4) of section 6.22 and section 331.25 of the statutes are amended to read: (5.12) (2) The fees for publishing notices of primary elections and for publishing all other matters relating to primary elections shall be * * * one dollar per folio for the first insertion and * * seventy cents per folio for the subsequent insertion; provided that in counties containing more than two hundred thousand population the compensation for publishing all said notices shall be at the commercial rates prevailing from time to time for such publications of said insertions of notices.

(6.22) (4) The compensation to be paid for all publications pursuant to sections 6.21 and 6.22 shall be * * * one dollar per square for weekly papers, and one dollar per square for the first publication, and * * * seventy cents per square for each subsequent publication in daily papers, * * * provided, that * * in counties containing more than two hundred thousand population the compensation for publishing all said notices shall be at the * * * commercial rates pre-
