

development of the surrounding area, unless the person, partnership, firm, association, or corporation before or at the time of such sale, shall have informed the purchaser in writing that the lot or parcel of land to be sold abuts on a private street, alley, way or common that has not been dedicated on a duly approved plat or is not required to be maintained as such by either said town or county.

(2) Any person, partnership, firm, association or corporation violating any of the provisions of this section shall, upon conviction thereof, be punished by a fine not exceeding two hundred dollars or by imprisonment in the county jail for not less than ten days or more than thirty days.

SECTION 3. This act shall take effect upon passage and publication.

## CHAPTER 308.

AN ACT to amend paragraph (a) of subsection (9a) of section 101.10 of the statutes, relating to the establishment and maintenance of local free employment offices.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Paragraph (a) of subsection (9a) of section 101.10 of the statutes is amended to read: (101.10) (9a) (a) Any county, city, town or village may enter into an agreement with the Wisconsin industrial commission for such period of time as may be deemed desirable for the purpose of establishing and maintaining local free employment offices, and it shall be lawful for any county, city, town or village to appropriate and expend the necessary money and to permit the use of public property for the joint establishment and maintenance of such offices as may be agreed upon, *or in counties containing two hundred fifty thousand inhabitants or more in any city, town or village therein to purchase a site and construct necessary buildings.* Provided, however, that no local free employment office shall be established by the industrial commission in any county *containing two hun-*

*dred fifty thousand inhabitants or more, or in any city, town or village, to be maintained in whole or in part by public funds unless such county, city, town or village, shall jointly or severally agree to furnish as a minimum in the joint enterprise, suitable quarters for such office, which must be approved by the industrial commission and to pay all expenses for such quarters such as rent, heat, light, furniture, telephone rental and janitor service. The industrial commission may defray all other expenses in connection with such office. Provided, further, that in any county, city, village or town therein, wherein there is a citizens' committee on unemployment, such committee shall have the power to rent, lease, purchase or construct necessary buildings for the joint establishment and maintenance of such free employment office.*

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 309.

AN ACT to appropriate a sum of money to the executive department as an emergency appropriation for the fiscal year ending June 30, 1927.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is appropriated from the general fund to the executive department five hundred dollars as an emergency appropriation for operation, in addition to all other sums heretofore appropriated for that purpose, for the fiscal year ending June 30, 1927.

SECTION 2. This act shall take effect upon passage and publication.
