

court review of general orders of the industrial commission shall apply to all general orders adopted pursuant to chapter 102 of the statutes.

102.40 Reports furnished to the industrial commission pursuant to the requirements of chapter 102 of the statutes shall not be admissible as evidence in any action arising out of the death or accident reported.

102.41 Every employer and every insurance company that fails to keep the records or to make the reports required by chapter 102 of the statutes or that knowingly falsifies such records or makes false reports shall forfeit and pay into the state treasury a sum not less than ten dollars nor more than one hundred dollars for each offense.

SECTION 3. This act shall take effect upon passage and publication.

## CHAPTER 311.

AN ACT to create the Black Hawk Refuge for wild life in Green Lake county.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The following described premises located in Green Lake county, shall be known as "Black Hawk Refuge", viz: Beginning at an iron stake, said iron stake being north 45°, east 30 chains and 4 links from the center of section 12, town 15 north, range 12 east, from which point of commencement also a white oak 19 inches in diameter bears north 7° 30' west, 1.02¾ chains, and a white oak 11 inches in diameter bears south 81° 20' west 25½ links, thence north 83° 20' east, 11.94 chains to an iron stake, thence north 8.82 chains to the shore of Green Lake, thence westerly along the shore of Green Lake to a point on said shore due north of the place of beginning, thence south 8.82 chains to the place of beginning, containing ten acres of land more or less, together with right for vehicles and persons to travel from west line of land conveyed to and over a strip two rods wide from such land to the right of way heretofore purchased by first party and

over such purchased right of way to the public highway, being place now traveled from such tract to such highway. Gates to be kept closed at all times. Also, lot 61 in Oakwood Beach, Green Lake county, Wisconsin, according to the recorded plat thereof, and containing approximately 34.13 acres, said acreage including a portion of Spring Lake, as shown on the recorded plat thereof. Also a permanent easement over the following described property: A strip of land 2 rods wide and 80 rods long of the west side of the northeast quarter of the southwest quarter of section 12, town 15 north, range 12 east. No person shall at any time, or in any manner, hunt or trap any game within said refuge, nor remove trees or fauna without consent of the conservation commission.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 312.

AN ACT to create section 43.52 of the statutes, authorizing cities, towns and villages to maintain musical bands and to levy taxes therefor.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to read: 43.52 (1) Any city, town or village may provide for the organization, equipment, maintenance or employment of a municipal band for musical purposes and for such purpose may levy a tax which shall not exceed in any year one mill on all the taxable property in such municipality.

(2) No city, town or village shall have power to levy such tax unless the question of such levy shall have been approved by the electors thereof at a regular municipal election or at a special election held as provided in section 10.43. The question submitted to the voters shall state the specific amount of money to be levied therefor.

(3) After the voters have once approved such levy, the city, town or village shall continue making a similar levy each year
