Section 1. The introductory paragraph to subsection (1) and subsections (2) and (3) of section 20.63 of the statutes are amended to read: (20.63) (1) (introductory paragraph) * * * For the fiscal year beginning July 1, * * 1927 * * * twelve thousand * * * five hundred * * dollars, and for the fiscal year beginning July 1, 1928, twelve thousand five hundred dollars, to carry into effect its functions relative to the state library. Of this there is allotted:

- (2) On * * * July 1, 1926, six thousand five hundred dollars, and for the fiscal year beginning July 1, 1927, six thousand five hundred dollars, and for the fiscal year beginning July 1, 1928, six thousand five hundred dollars for the purchase of such law books, books of reference, and works on political science and statistics, and for binding books, for the state library and the justices of the supreme court, as the said board shall think reasonably necessary or desirable. Expenditures from this appropriation shall be certified to the secretary of state by the state librarian.
- (3) On July 1, 1923, three thousand eight hundred dollars, and for the fiscal year beginning July 1, 1927, two thousand two hundred dollars for the purchase of library stacks and shelving and permanent property for the state library. Expenditures from this appropriation shall be certified to the secretary of state by the state librarian and the state chief engineer.

SECTION 2. This act shall take effect July 1, 1927. Approved April 14, 1927.

CHAPTER 33.

AN ACT to amend paragraph (h) of subsection (8) of section 20.17 of the statutes, relating to funds for the state tuberculosis sanatorium and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (h) of subsection (8) of section 20.17 of the statutes is amended to read: (20.17) (8) (h) On July 1, 1921, ten thousand eight hundred dollars for the purchase and installation of a water softening plant; two thousand five hundred

dollars for an air compressor; one thousand five hundred dollars for remodelling the employes' dining room; two thousand dollars for an X-ray machine; and twenty thousand dollars for the construction of an addition to the power house and for the purchase and installation of power plant equipment.

Section 2. This act shall take effect upon passage and publication.

CHAPTER 34.

AN ACT to amend subsection (1) of section 56.08 of the statutes, relating to employment of prisoners in a county jail.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (1) of section 56.08 of the statutes is amended to read: (56.08) (1) In any county having no workhouse any person, and in all other counties any female person, convicted of any offense and sentenced to imprisonment in the county jail shall be committed to hard labor; provided that the court may order the imprisonment, or a part thereof, to be in actual and ordinary confinement, unless the jail to which the commitment is made shall have been declared inadequate or unfit by the state board of control pursuant to section 46.17. Every such prisoner, for such period of time as he may have been sentenced to hard labor, shall be required to do and perform any suitable labor provided for by the sheriff anywhere within said county; but the hours of labor in farm work shall be not less than ten nor more than twelve hours, and in all other work not more than ten hours, each day.

Section 2. This act shall take effect upon passage and publication.
