(f) So much of the amounts severally specified as may be necessary for the construction and equipment of buildings, and permanent improvements, as follows: On July 1, 1921, ninety thousand dollars for an addition to the chemistry building and equipment; thirty-one thousand dollars for agricultural buildings, equipment, *a feed storage building*, and spur track; fifteen thousand dollars for boiler and equipment for dairy power house; and on July 1, 1922, sixteen thousand dollars for a barn for beef cattle; forty thousand dollars for an electric substation, equipment, and distributing system; and twenty-six thousand five hundred

dollars for tunnels and equipment to connect the hospital and central heating station.

(g) On July 1, \* \* \* 1927, \* \* \* *ten thousand \* \* \* dollars, and on July 1, 1928, ten thousand dollars* for purchase of land.

(2) (a) Annually, beginning July 1, \* \* \* 1927, two hundred \* \* \* *eighty thousand dollars \* \* \** for operation, and in addition thereto all moneys received by each and every person for or in behalf of the board of regents of the university, as university extension fees, including fees for correspondence study instruction, class instruction, lecture instruction, *medical extension*, visual instruction materials, musical and dramatic materials, extension texts and bulletins, traveling instructors, and extension teachers serving local continuation schools and other organizations, *and for duplicating service rendered by the extension division of the university*, shall, unless otherwise provided by law, be paid within one week of receipt into the university fund income, and are appropriated therefrom, and added to this appropriation.

(b) On July 1, \* \* \* 1927, \* \* \* *fifty thousand one hundred seventy dollars, and on July 1, \* \* \* 1928, \* \* \* nineteen thousand eight hundred fifteen dollars \* \* \** for the purchase of books, educational apparatus, furniture and furnishings, and other necessary equipment.

(d) On July 1, \* \* \* 1927, five thousand five hundred dollars, and on July 1, \* \* \* 1928, five thousand five hundred dollars \* \* \* for medical extension.

(e) On July 1, 1923, one hundred \* \* \* *fifty thousand dollars for the erection of a university extension building and the securing of a necessary site therefor in the city of Milwaukee \* \* \**, and on July 1, 1927, *one hundred seventy-five thousand dollars for the completion of the building and the purchase and installation of equipment.*

(3) (a) Annually, \* \* \* *beginning July 1, \* \* \* 1927, \* \* \* thirty thousand dollars, for farmers' institutes, authorized by subsection (2) of section 36.215. Of this sum ten thousand dollars shall be annually used only for the purpose of more adequately providing for institutes on cooperative marketing of farm products and the business problems of cooperatives.*

(b) Annually, beginning July 1, \* \* \* 1927, \* \* \* *sixty thousand dollars \* \* \** for the dissemination of agri-

cultural knowledge and traveling schools of agriculture, as provided in section 36.215.

(d) For the branch agricultural experiment stations, established by the board of regents of the university, at Ashland Junction, Marshfield, and Spooner, to promote the agricultural development of the regions embraced in the respective soil types represented by these stations, the following several sums:

Annually, beginning July 1, \* \* \* 1927, twenty-five thousand \* \* \* six hundred \* \* \* dollars for operation.

On July 1, \* \* \* 1927, \* \* \* one thousand \* \* \* six hundred \* \* \* dollars, and on July 1, \* \* \* 1928, \* \* \* one thousand \* \* \* six hundred \* \* \* dollars \* \* \* for property repairs and maintenance.

On July 1, \* \* \* 1927, two thousand \* \* \* eight hundred \* \* \* dollars, and on July 1, \* \* \* 1928, two thousand \* \* \* eight hundred \* \* \* dollars \* \* \* for construction of necessary buildings and permanent improvements, except the purchase of land.

(i) *Annually, beginning* \* \* \* July 1, \* \* \* 1927, two thousand five hundred dollars \* \* \* for the preparation, purchase, sale, and distribution of hog cholera serums, as provided in section 36.21 and for the investigation of swine diseases; and all moneys received under section 36.21 shall be paid, within one week after receipt, into the university fund income, and are appropriated therefrom and added to the appropriations for carrying out the provisions of said section.

(p) On July 1, \* \* \* 1927, six thousand nine hundred fifty dollars, and on July 1, \* \* \* 1928, six thousand nine hundred fifty dollars \* \* \* for experimental work, necessary equipment, and general expenses incurred in investigating the cultural methods employed in the tobacco industry and dis-

eases affecting the tobacco plant, and for the general improvement and advancement of the tobacco industry of the state.

(5) (a) All moneys received by each and every person, for or on account of dormitories and dining halls at the university, *including the sale of supplies used by students*, shall be paid within one week after receipt into the university fund income, and are appropriated therefrom for \* \* \* operation, \* \* \* maintenance, and *capital expenditures* of such dormitories and dining halls.

(c) All moneys received by each and every person for or on account of the athletic council or any similar organization of the university shall be paid within one week after receipt into the university fund income, and are appropriated therefrom for the purposes of such athletic council, or other similar organization of the university, respectively, for carrying out its powers, duties and functions. \* \* \*

(7) *Annually, beginning* \* \* \* July 1, \* \* \* 1927, eight hundred dollars \* \* \* for the upkeep of Memorial Park, to be expended under the direction of the Wisconsin Memorial Park Commission.

(9) On July 1, \* \* \* 1927; \* \* \* *fifty* thousand dollars, and on July 1, \* \* \* 1928, \* \* \* *fifty* thousand dollars \* \* \* to encourage scientific investigation and productive scholarship as provided by section 36.0625.

(35.34) (1) Job printing includes labels, envelopes, letterheads, noteheads, billheads, blanks of all kinds, blank books, folders, circulars, postal cards, announcements, instructions, cards for card catalogues, indexes, questions for bar, medical, civil service, teachers' or other examinations, slips, pay rolls, statements, tables of receipts and disbursements, certificates, election and other notices, sample ballots, lists of candidates, and such other printing not specified in this chapter as may be permitted or required by law and necessary for the use of the University of Wisconsin or any state normal school, or the state historical society, or any state officer, department, board, commission or commissioner, where it does not interfere with the multigraph, *multicolor*, \* \* \* and mimeograph operation in the superintendent of public property's offices *and the university of Wisconsin*, including such binding as may be needed in connection with such printing; also all binding and rebinding necessary to preserve books, documents, manuscripts, periodicals and other material collected by any state officer or department or by the state historical society. The printing board shall order all such printing, which it shall determine is needed, to be done by the state printer upon receiving printer's copy and the necessary requisitions therefor from the respective institutions, boards, commissions and officers. The form of all blank pay rolls and expense sheets to be used by any agent, officer, board, commission or commissioner of the state shall be prepared by the secretary of state.

(36.06) (6) For the purpose of providing dormitories and commons and a field house for university purposes, *and completing the memorial union*, and to enable the construction, financing and ultimate acquisition thereof, the regents are authorized and empowered to lease university lands to a nonprofit sharing corporation or corporations for a term not exceeding fifty years, upon condition that such corporation or corporations shall construct on such leased land such building, improvements or equipment for dormitories, commons, \* \* \* field house, *or addition to the memorial union* as the regents shall designate or approve, and shall lease the same to the regents upon satisfactory terms as to the current rental, maintenance and ultimate purchase by the regents. *For the purpose of equipping the memorial union, the regents are authorized and empowered to lease the lands and the*



*memorial union buildings now under construction to a nonprofit sharing corporation or corporations for a term not exceeding fifty years upon condition that such corporation or corporations shall completely equip and furnish such memorial union building and lease the same so equipped and furnished to the regents upon such terms as to the current rental, maintenance, and ultimate purchase by the regents, as may be in the best interests of the university in the judgment of the regents. Revenues derived from the operation by the regents of such dormitories, commons, memorial union, or field house shall be applied to the payment of such rentals, any surplus which from time to time may accrue to be applied toward the purchase price of the building, equipment, or improvements, or accumulated for subsequent application upon the purchase price. The regents are authorized and empowered to enter into such leases or contracts with such corporation or corporations for the above purposes as they shall deem for the best interest of the university; provided, that nothing herein contained shall authorize the regents to incur any state debt for the construction of such buildings, equipment, or improvements. The plans for buildings and all contracts and leases made pursuant to this subsection shall before they are finally adopted or become effective be submitted to the state engineer and the governor and have their written approval. Such buildings, equipment, and improvements so erected on university lands and devoted to university purposes, and the leasehold interest in such lands shall be exempt from taxation.*

(20.41) (1) (q) For the construction and equipment of buildings and permanent improvements, the following amounts, provided that any of the amount specified, not needed for the original purpose may, with the consent of the governor, be added to any one or more of the other appropriations in this paragraph, and shall thereby become a part of such appropriation or appropriations:

On July 1, 1927, two hundred fifty thousand dollars for the construction and equipment of a mechanical engineering building; sixty thousand dollars for rebuilding the tank house; eleven thousand dollars for a feed storage building; fourteen thousand five hundred dollars for an addition to the agricultural library building; five thousand dollars for radio towers; twenty-five thousand dollars for equipment for the dairy building; seventeen thousand dollars for remodeling the ventilating system in the chemistry building; eighteen thousand dollars for a high pressure steam line to the union memorial building; twelve thousand dollars for electrical distributing system; twenty-two thousand two hundred dollars for tunnels and equipment; eighty-eight thousand five hundred dollars for two additional boilers, equipment, breeching, and connections at the central heating station; and fifty thousand dollars for remodeling and repairing released space.

On July 1, 1928, three hundred twenty-seven thousand dollars for the construction and equipment of a mechanical engineering building; and thirty thousand dollars for constructing foundations and moving and installing the engineering equipment.

(5) (d) All moneys received by each and every person for or on account of the memorial union shall be paid within one week after receipt into the university fund income, and are appropriated therefrom as a revolving appropriation or operation, maintenance, and capital expenditures of the memorial union.

(10) (c) On July 1, 1927, twelve thousand five hundred dollars, and on July 1, 1928, twelve thousand five hundred dollars for permanent property and improvements for the Wisconsin general hospital.

(4) On July 1, 1927, thirty-four thousand one hundred sixty-three dollars, and on July 1, 1928, thirty-four thousand one hundred sixty-three dollars for operation, maintenance, and permanent property for the hygienic laboratory.

## CHAPTER 526.

AN ACT to amend paragraph (a) of subsection (1), and paragraph (a) of subsection (2) of section 40.42, and subsection (3) of section 40.53; and to create subsection (9) of section 40.53 and section 40.535 of the statutes, relating to the tuition to be charged in high schools and state graded schools.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Paragraph (a) of subsection (1) and paragraph (a) of subsection (2) of section 40.42 and subsection (3) of section 40.53 are amended to read: (40.42) (1) (a) The school board of any school district maintaining a first-class state graded school as defined in section 40.41, which in addition to the regular course of study provided for state graded schools, offers a course of instruction in the ninth or tenth, or in the ninth and tenth grades which has been adopted by the board and approved by the state superintendent, shall admit nonresident pupils to the privileges of the ninth or tenth or the ninth and tenth grades in such first-class state graded school whenever the teaching and seating facilities will warrant, provided that the parents or guardians of such pupils live in a school district not maintaining a public high school or a state graded school of the first class offering instruction in the ninth or tenth or the ninth and tenth grades, and provided such pupils have completed the course of study offered in the home district, which must have been at least
