- (k) To make such reasonable rules and regulations and to do all other things that may be necessary and proper to carry out the purposes of this section.
- (3) The county board of any county establishing and maintaining a county forest reserve shall co-operate with the state conservation commission in all ways possible, and the county agent of such county shall carry on a reforestation educational program among farmers, other landowners and school children.
- (4) All provisions of the statutes covering fires, fishing, hunting and trapping shall apply to county forest reserves.

Section 2. This act shall take effect upon passage and publication.

CHAPTER 58.

AN ACT to amend sections 10 and 14 of chapter 23 of the laws of 1895, as amended, relating to the salaries of the judge, reporter and clerk of the western municipal court of Waukesha county.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Sections 10 and 14 of chapter 23 of the laws of 1895, as amended, are further amended to read: (Chapter 23, Laws of 1895) Section 10. The judge of said court may appoint, and from time to time remove, a phonographic reporter of said court, who shall not be a relative of said judge, who shall take and subscribe the oath of said office prescribed in the constitution, and who shall be furnished with all necessary stationery and shall attend only when required by said judge, and perform such duties as he may require. Said judge shall fix his compensation, not exceeding * * that of stenographic reporters in the circuit court which shall be in full compensation for his services and for making such transcripts of his shorthand notes as may be required by the judge; and he shall furnish to and may charge persons requiring them, like transcripts at a price not exceeding five cents per folio. Three-fourths of said reporter's

per diem compensation shall be paid by the county of Waukesha and one-fourth by the city of Oconomowoc, quarterly.

Section 14. The salary of the judge of said municipal court shall be the sum of fifteen hundred dollars per annum, to be paid as follows: Three-fourths of the same to be paid out of the county treasury of Waukesha county, and one-fourth to be paid out of the treasury of the city of Oconomowoc, to be paid monthly at the end of each month, out of said county and city treasuries respectively. The salary of the clerk of said court shall be nine hundred dollars per annum, to be paid in like manner and in like proportions as the salary of the judge; which said salaries shall be in full for all services rendered by said judge and clerk of said municipal court. Provided, however, that the county board of Waukesha county may at any time increase the salary of the judge, clerk and reporter of said court. The said court is authorized to tax and collect fees as follows: For all services rendered by said court in civil and criminal actions when exercising the powers of a justice of the peace, the fees allowed to justices of the peace, except as hereinafter provided. For hearing and deciding any motion, fifty cents each; for issuing each venire, fifty cents; for making and recording all necessary orders, fifty cents each; for receiving and recording verdict of the jury, fifty cents; taking and approving bail, fifty cents; each commitment, fifty cents; drawing jury in every case, fifty cents; for services of clerk, one dollar in each criminal case, and one dollar in each civil case; and the same shall be paid as other costs in civil or criminal cases are paid; and the said clerk shall pay the same into the county and city treasuries, to apply on the salary of the judge and clerk as follows: All costs imposed and collected in bastardy and criminal cases, arising under the laws of the state. shall be paid into the county treasury, and all costs imposed and collected in cases arising under the charter and ordinances of any city or village, shall be paid into the treasury of the city or village under whose charter, by-laws or ordinances said case arose, and all costs collected in civil cases shall be paid as follows: Three-fourths of the same into the county treasury of Waukesha county, and one-fourth into the treasury of the city of Oconomo-The clerk of said court shall keep an accurate statement of all such costs thus collected, and file the same in the county clerk's office at the end of each month under his hand and the

seal of said court; and shall, at the same time, pay over all such moneys as provided for in this act.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 59.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Sections 10 and 14 of chapter 22 of the laws of 1895, as amended, are further amended to read: (Chapter 22, Laws of 1895) Section 10. The judge of said court may appoint, and from time to time remove, a phonographic reporter for said court, who shall not be a relative of said judge, who shall take and subscribe the oath of office prescribed in the constitution, and who shall be furnished with all necessary stationery and shall attend only when required by said judge, and perform such duties as he may require. Said judge shall fix his compensation, not ex-* * that of stenographic reporters in the circuit court, which shall be in full compensation for his services and for making such transcripts of his shorthand notes as he may be required by the judge; and he shall furnish to, and may charge persons requiring them, like transcripts at a price not exceeding five cents per folio. Three-fourths of said reporter's per diem compensation shall be paid by the county and one-fourth by the city of Waukesha quarterly.
