### CHAPTER 165.

AN ACT to create section 29.626 of the statutes, relating to trespassing on lands bordering streams stocked with fish obtained from state fish hatcheries.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to read: 29.626 In an action against a person for damages sustained from trespassing on lands bordering streams stocked by the consent of owner of such lands, with fish received from a state fish hatchery, where such damage shall exceed two dollars, the trespasser shall be liable for double the amount of such damage and all the taxable costs; and where the damage sustained is two dollars or less the trespasser shall be liable for the amount of such damage and the costs not to exceed the amount of the damage.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 166.

AN ACT to amend subdivision 2 of paragraph (b) of subsection (9) and paragraph (c) of subsection (10) of section 62.13 of the statutes, relating to police and firemen's pension funds.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subdivision 2 of paragraph (b) of subsection (9) and paragraph (c) of subsection (10) of section 62.13 of the statutes are amended to read: (62.13) (9) (b) 2. The board shall meet at least once annually in January and select from its mem-

bers a president and a secretary, and shall fill vacancies in such offices. The city treasurer shall be ex officio treasurer of such board, and as such, custodian of the fund and all securities and property belonging thereto. He shall keep books of account thereof in such manner as the board shall direct. Such books shall always be open to inspection by the board or a member thereof. The city treasurer shall be liable on his official bond for the performance of such duties.

(10) (c) When the amount in said fund shall be *one hundred fifty thousand dollars* it shall be retained as a permanent fund, and thereafter only the income therefrom, with the other revenues of said fund, shall be available for the payment of pensions. The council may then diminish the amount paid into said fund from taxation of fire insurance companies or agents, but to such extent only as will leave sufficient income to the said fund to meet the pension requirements.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 167.

AN ACT to amend section 14.23 of the statutes, relating to Armistice Day.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 14.23 of the statutes is amended to read: 14.23 The governor, by proclamation, may set apart one day each year to be designated as arbor and bird day, and may request its observance by all schools, colleges and other institutions by the planting of trees, the adornment of school and public grounds, and by suitable exercises having for their object the advancement of the study of arboriculture, the promotion of a spirit of protection to birds and trees, and the cultivation of an appreciative sentiment concerning them. He may also set apart, in said manner, one day in each year to be observed as labor day. *The governor shall annually issue a proclamation calling attention to the fact that the eleventh day of November is the anniversary of armistice day, and requesting the people*
