ice in Rock river and Lake Sinnissippi in Dodge county, between sunrise and sunset, for carp and suckers, with the use of dip nets only, of not more than eight feet in diameter with a mesh of not less than three inches, which shall be removed from the water at sunset; any person may fish for perch through the ice in Lake Nakomis, in Lincoln and Oneida counties, and in big and little Arbor Vitae lakes in Vilas county; and any person may spear carp and suckers in Beaver Dam lake between sunrise and sunset.

SECTION 2. This act shall take effect upon passage and publication.

ordinance or resolution providing for such reward, and present an affidavit to such officer stating that said bill, ears, body or head are of the animal killed by him, and that he has not spared the life of any such animal or bird within his power to kill.
