**CHAPTER 14.**

AN ACT to amend subsection (4p) of section 102.09 of the statutes, relating to dependency of the children of divorced parents under the workmen's compensation act.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Subsection (4p) of section 102.09 of the statutes is amended to read: (102.09) (4p) The following shall be conclusively presumed to be solely and wholly dependent for support upon a deceased employe: A wife upon a husband with whom she is living at the time of his death; a husband upon a wife with whom he is living at the time of her death; a child or children under the age of eighteen years (or over said age, but physically or mentally incapacitated from earning), upon the parent with whom he or they are living at the time of the death of such parent, there being no surviving dependent parent. In case of divorce the charging of \* \* \* *any portion of the support and maintenance of a child upon one of the divorced parents, or any voluntary contribution toward the support of a child by such divorced parent, or an obligation to support a child by such divorced parent shall be held to constitute a living with the parent so charged.*

SECTION 2. This act shall take effect upon passage and publication.

**CHAPTER 15.**

AN ACT to amend section 289.32 and to create section 289.325 of the statutes, relating to log and timber liens.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 289.32 of the statutes is amended to read: 289.32 Appeals may be taken from all judgments rendered by justices of the peace, and the judgment of circuit and county courts hereunder may be revised by the supreme court as in ordinary civil actions. \* \* \*

**SECTION 2.** A new section is added to the statutes to read: 289.325 All persons furnishing supplies necessary for the performing of the labor and services upon any property mentioned in section 289.18, at the request of the person engaging such labor or services, shall have the right of lien therefor and may enforce the same by action as herein provided for the enforcement of liens upon logs and timber.

**SECTION 3.** This act shall take effect upon passage and publication.

### CHAPTER 16.

AN ACT to repeal chapter 381, laws of 1917, conferring civil and criminal jurisdiction on the county court of Trempealeau county.

**SECTION 1.** Chapter 381, laws of 1917, is repealed.

**SECTION 2.** This act shall take effect upon passage and publication.

### CHAPTER 17.

AN ACT to amend section 256.17 of the statutes, relating to Armistice Day as a legal holiday.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**SECTION 1.** Section 256.17 of the statutes is amended to read: 256.17 The first day of January, the twenty-second day of February, the thirtieth day of May, the fourth day of July, the eleventh day of November, the twenty-fifth day of December, the day appointed by the governor as Labor day and by the governor or the president of the United States as a day of public thanksgiving in each year, the day of holding the September primary election, and the day of holding the general election in
