All such votes heretofore cast not involved in any litigation are hereby validated.

CHAPTER 244.

AN ACT to create subsection (6) of section 102.31 of the statutes, relating to workmen's compensation insurance companies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

A new subsection is added to section 102.31 of the statutes, to read: (102.31) (6) If any corporation licensed to transact the business of workmen's compensation insurance shall fail promptly to pay claims for compensation for which it shall become liable or if it shall fail to make reports to the industrial commission as provided in section 102.38, the industrial commission may recommend to the commissioner of insurance that the license of such company be revoked, setting forth in detail the reasons for its recommendation. The commissioner shall thereupon furnish a copy of such report to the corporation and shall set a date for a hearing, at which both the corporation and the industrial commission shall be afforded an opportunity to present evidence. If after such hearing the commissioner is satisfied that the corporation has failed to live up to all of its obligations under this chapter, he shall promptly revoke its license; otherwise he shall dismiss the complaint.
