said state treasurer, a sworn statement of the number of gallons of motor vehicle fuel sold by him or them during the preceding calendar month, and also on forms prescribed by the state treasurer a statement showing the amount of gasoline purchased, the name of the company from whom purchased, the initials, number and gallonage of each car purchased during the preceding month. and any additional information deemed necessary by the state treasurer. Such statements shall be sworn to by one of the principal officers in case of domestic corporations; by the resident general agent or agents, attorney in fact, or chief accountant or officers in case of a foreign corporation; by the managing agent or owner in case of a firm, association or individual; and shall contain a statement of the quantities of motor vehicle fuel sold within this state from his or their respective places of business, and if any of such motor vehicle fuel has been sold and delivered by such dealer to customers in the original packages, whether in tank cars, barrels or other packages, and in the same form and condition in which the same was imported, said statement shall show the amount of motor vehicle fuel so sold, and the names and addresses of the persons, firms or corporations to whom the same was sold.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 321.

AN ACT to amend paragraphs (b) and (c) of subsection (5) of section 29.18 of the statutes, relating to close season for muskrats in Marathon and Waushara counties.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Paragraphs (b) and (c) of subsection (5) of section 29:18 of the statutes are amended to read: (29.18) (5) Muskrats:

(b) In all other counties south of north line of Buffalo, Trempealeau, Jackson, Wood, Portage, Waupaca, Outagamie, Brown, and Kewaunee counties, except that in the towns of Fox Lake and Trenton in Dodge county where the open season shall be February first to April first in each year, and except that on Horicon marsh in Dodge county there shall be no open season for muskrat, including muskrat on socalled muskrat farms not legally operated or on muskrat farms established after July 1. 1927, until January 1. 1933, and except in Fish and Silver lakes in the town of Marion in Waushara county where there shall be no open season.

March 1 to April 10 in even-numbered years

(c) In all other counties, except that there shall be no open season on Lake Mayflower and Lake Norrie in the town of Norrie and on Pike lake in the towns of Reid and Elderon in Marathon county.

## CHAPTER 322.

AN ACT to amend subsection (4) of section 357.13 of the statutes, relating to insane person guilty of criminal offenses.

If it shall be determined, \* \* \* pursuant to any such re-examination, that the insanity or feeble-mindedness of such accused person is incurable he shall be treated and disposed of as persons incurably insane or feeble-minded are required by law to be treated; but no such person shall be removed or discharged from said hospital or home except upon the order of the court having jurisdiction \* \* \* over such person for trial, sentence or commitment.
