

to the Dells, the bays and bayous connected therewith and in the waters of La Fayette, Iowa and Green counties; in the waters of Lake Winnebago in Fond du Lac, Calumet and Winnebago counties; in Buffalo lake, Marquette county; in Puckaway lake in Marquette and Green Lake counties; in Lake Poygan in Winnebago and, Waushara counties; in Lakes Winneconne, Big and Little Butte des Morts in Winnebago county; in the Fox river in Marquette, \* \* \* Green Lake, Waushara and Winnebago counties *and in Columbia county except where it flows through Park lake (in which the general laws shall be applicable)*; in the Wolf river in Winnebago county and in Waupaca county as far as the city limits of New London; and in the Rock and Crawfish rivers and in Lake Ripley and Lake Koshkonong in Rock, Jefferson and Dodge counties. During the period from March first to May twenty-eighth, both dates inclusive, live or dead minnows shall not be used for bait in any of the above waters specified in Jefferson county. There shall be no close season for hook and line fishing *in Park lake in Columbia county and in Lake Wisconsin in Columbia and Sauk counties* for perch, bluegills, sunfish, crappies and bullheads. In Kenosha county the open season for the varieties of fish described in subsections (6) and (7) of section 29.19 shall commence on May twenty-ninth.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 332.

AN ACT to amend section 156.02 and to create section 156.015 of the statutes, relating to registration of student embalmers.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section 156.02 of the statutes is amended to read: 156.02 Application shall be in writing, on blanks prescribed by the board, accompanied by a photograph of applicant, and ten dollars, and proof that the applicant is of good moral character, a citizen of the United States, twenty-one years of age or over, has an education equivalent to graduation from high school, and has

had either at least two years' practical experience in embalming and disinfecting under a licensed embalmer, or at least \* \* \* *twelve* months of practical experience in embalming and disinfecting under a licensed embalmer, and has a diploma of graduation from a school of embalming which requires as a prerequisite to graduation the completion of a course of study of not less than twenty-four weeks' duration, approved by the state board of health; provided, that any school of embalming situated within the state of Wisconsin, and having been in existence and operation in said state for at least five years immediately preceding the passage of this act, and giving a course of thorough instruction on the subjects, of anatomy, bacteriology, autopsy, chemistry, professional embalming, funeral directing and public health for a period of at least twenty-four weeks, consisting of six hundred sixty hours of instruction, and complying with the rules and regulations promulgated by the state board of health for the conducting of embalming schools, shall be approved by the state board of health as an accredited school.

SECTION 2. A new section is added to the statutes to read: 156.015 Every person desiring to study under a licensed embalmer the practice of embalming as defined in section 156.01 shall make a written application to the state board of health for registration as a student embalmer, giving such information as the said board may, by regulation, require for such registration. Each application shall state the age of the applicant, and shall be accompanied by a fee of one dollar and the certificate of three reputable citizens (one of whom shall be a licensed embalmer) that the proposed applicant is of good moral character, a citizen of the United States, and has an education equivalent to graduation from high school. Upon receipt of such application by the board, the applicant shall be registered as a student embalmer.

SECTION 3. This act shall take effect upon passage and publication.
