CHAPTER 295.

AN ACT to amend 59.57 (11) and (11a) of the statutes, relating to register of deeds' fees for recording exhibits by use of photostatic or similar processes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

59.57 (11) and (11a) of the statutes are amended to read:

59.57 (11) For ordinary exhibits or sketches, attached to or incorporated in any deed or other instrument not exceeding a page 10 inches by 16 inches, \$5, and those exceeding this size, \$10; *except where a photostatic, photographic or similar process is used by the register of deeds, such fee shall be one-half of such amounts.*

(11a) For exhibits, drawings or plats and printed matter, attached to any deed or other instrument, not exceeding a page 10 inches by 16 inches, \$10, and for those exceeding this size, \$20; *except where a photostatic, photographic or similar process is used by the register of deeds, such fee shall be one-fourth of such amounts.*

CHAPTER 296.

AN ACT to amend 174.07 (1) of the statutes, relating to dog licenses and collar tags.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

174.07 (1) of the statutes is amended to read:

174.07 (1) Upon payment of the required dog license tax on any dog the collecting officer shall execute and issue to the taxpayer a license for such dog which shall be in the form prescribed by the department of agriculture and markets and shall state the date of its expiration, shall bear a serial number, the owner's name and address, and the name, sex, spayed or unspayed, breed and color of the dog licensed, *and a duplicate copy of the*

license shall be kept on file. At the same time he shall deliver to the licensee a metal tag which shall bear the same serial number as the license, the name of the county in which issued and the license year. The department of agriculture and markets shall contract for and have prepared and furnished annually to the county clerk of each county a sufficient number of such metal tags * * *. The cost of making * * * and furnishing said tags and * * * *the cost of printing all forms* shall be paid by the several counties out of the dog license fund.

CHAPTER 297.

AN ACT to amend 348.386 (1) and to create 348.386 (1a) of the statutes, relating to criminal trespass, unauthorized posting of no trespass signboards and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 348.386 (1) of the statutes is amended to read:

348.386 (1) Any person who shall enter into any growing or standing grain not his own, with firearms or permit his dog to enter into any such grain, without the permission of the owner or occupant of the land on which such grain is situate or any person who shall, without permission of the owner, hunt or shoot on the premises of another inclosed by a fence and used as a pasture for stock, or shall hunt or shoot upon any other land of another after being notified not to hunt or shoot thereon, shall be punished by a fine of not less than \$5 nor more than \$10 and in default of payment thereof, shall be imprisoned in the county jail not less than 10 days nor more than 30 days; provided, that this section shall not limit or any way affect civil liability on account of such trespass. Any owner or occupant of land may give the notice provided for in this section by maintaining signboards, at least one foot square, containing such notice *and bearing at the foot the name of the person giving the notice followed by the word "owner" or "occupant", as the case may be*, upon at least every 40 acres of the premises sought to be protected, in at least 2 conspicuous places, or by giving personal, written or verbal notice.
