by the President or the Congress and the husband or wife of such minor may execute in his or her own right, notes or mortgages, the payment of which is guaranteed or insured by the administrator of veterans' affairs or the federal housing administrator under the provisions of the Servicemen's Readjustment Act of 1944 or the National Housing Act. Such notes or mortgages when so executed shall not be subject to avoidance by such minor or the husband or wife of such minor upon either or both of them attaining the age of 21 because of the minority of either or both of them at the time of the execution thereof.

CHAPTER 170.

AN ACT to create 20.41 (22) and 36.21 (2) of the statutes, relating to experimental work in the control of Brucellosis, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.41 (22) of the statutes is created to read:

20.41 (22) BRUCELLOSIS RESEARCH AND STUDY. On July 1, 1945, \$50,000, and on July 1, 1946, \$50,000, as nonlapsible appropriations for the use of the college of agriculture for the study of and research into the causes, prevention and cure of bovine brucellosis (Bang's disease), and for the purpose of equipment, livestock, land and other supplies as may be necessary for the purpose of carrying on such study and research. The general fund shall be reimbursed for all expenditures under this subsection from the appropriation made on July 1, 1946, by section 20.60 (3a).

SECTION 2. 36.215 (2) of the statutes is created to read:

36.215 (2) The board of regents shall cause to be done, under the supervision of the dean of the college of agriculture, research and experimentation in the control of bovine brucellosis (Bang's disease), at such points within this state as may in its judgment be advisable. Such research shall include studies of the relative value of methods controlling such disease, particularly "test and slaughter", calfhood vaccination, adult animal vaccination, and

proper sanitary herd management, or various combinations of such procedures. Such research shall also include studies in cooperation with the state board of health and the university school of medicine to determine if undulant fever is transmissible to humans through milk from bovine animals which have been vaccinated with Strain 19 Brucella vaccine. To facilitate such work contracts may be entered into with the owners of not more than 100 herds of bovine animals of various classes for the supervised control of the animals therein and for the purchase of animals under conditions to be specified in such contracts which shall be retained for control purposes. Payment for such animals shall be made out of the appropriation in section 20.41 (22).

CHAPTER 171.

AN ACT to amend 218.01 (1) (d), (n), (o), (p), 218.01 (2) (c), 218.01 (2) (d) 1, 218.01 (2) (h), 218.01 (3) (a) 13, 17, 218.01 (6) (g) and to create 218.01 (8) (d) of the statutes, relating to motor vehicle dealers, manufacturers, definitions, bonds, fees, unfair cancellations, equitable adjustments, and providing penalties.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 218.01 (1) (d), (n), (o) and (p) of the statutes are amended to read:

218.01 (1) (d) "Sales finance company" means and includes any person, firm or corporation engaging * * * in the business, in whole or in part, of acquiring by purchase or by loan on the security thereof, or otherwise, retail instalment contracts from retail sellers in this state, including any motor vehicle dealer who sells any motor vehicle on an instalment contract or acquires any retail instalment contracts in his retail sales of motor vehicles.

(n) "Manufacturer" means any person, resident or nonresident
* * * who manufactures or assembles motor vehicles
* * *

(o) "Distributor" or "wholesaler" means a person, resident or nonresident * * * who in whole or part, sells or distrib-
