CHAPTER 313

AN ACT to renumber 252.06 (Twenty-fifth Circuit); to renumber and amend 252.06 (Twenty-fourth Circuit); to amend 252.06 (Sixth Circuit), (Seventh Circuit), (Twelfth Circuit), (Thirteenth Circuit), (Seventeenth Circuit) and (Eighteenth Circuit); and to create 252.06 (Twenty-fifth Circuit) of the statutes, relating to redistricting judicial circuits, terms of court and the election of a judge for the twenty-fifth circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 252.06 (Sixth Circuit) of the statutes is amended to read:

252.06 SIXTH CIRCUIT. In the county of La Crosse on the third Monday in May and the fourth Monday in October; in the county of Monroe on the first Monday in May and the second Monday in September; * * * in the county of Vernon on the third Monday in April and the second Monday in October.

SECTION 2. 252.06 (Seventh Circuit) of the statutes is amended to read:

252.06 SEVENTH CIRCUIT. In the county of Waupaca on the first Monday in May and the third Monday in October; * * * in the county of Portage on the second Monday in April and the fourth Monday in September; in the county of Wood on the third Monday in March and the first Monday in December.

SECTION 3. 252.06 (Twelfth Circuit) of the statutes is amended to read:

252.06 TWELFTH CIRCUIT. In * * * the county of Green on the fourth Monday of February and the fourth Monday of October; and in the county of Rock on the third Monday of March and the third Monday of September.

SECTION 4. 252.06 (Thirteenth Circuit) of the statutes is amended to read:

252.06 THIRTEENTH CIRCUIT. In the county of Dodge on the first Monday of May and November; *in the county of Jefferson on the first Monday of February and the third Monday of September.*

SECTION 5. 252.06 (Seventeenth Circuit) of the statutes is amended to read:

252.06 SEVENTEENTH CIRCUIT. In the county of Jackson on the first Monday in May and November; in the county of Clark on the first Monday in March and on the first Tuesday after the first Monday in September; in the county of Juneau on the first Monday in April and October; in the county of * * * Adams on the first Monday of June and December.

SECTION 6. 252.06 (Eighteenth Circuit) of the statutes is amended to read:

252.06 EIGHTEENTH CIRCUIT. In the county of Fond du Lac on the first Monday in May and the first Monday in November; in Green Lake county on the third Monday in January and the first Monday in June * * *.

SECTION 7. 252.06 (Twenty-fourth Circuit) of the statutes is renumbered 252.06 (Twenty-third Circuit) and amended to read:

252.06 TWENTY-THIRD CIRCUIT. In the county of Eau Claire on the third Monday of March and the third Monday in September; *in the county of Trempealeau on the first Monday in March and the first Tuesday after the first Monday in September.*

SECTION 8. 252.06 (Twenty-fifth Circuit) of the statutes is renumbered 252.06 (Twenty-fourth Circuit).

SECTION 9. 252.06 (Twenty-fifth Circuit) of the statutes is created to read:

252.06 TWENTY-FIFTH CIRCUIT. In the county of Columbia on the third Monday in April and the fourth Monday in October; in the county of Marquette on the second Monday in February and the first Wednesday in September; in the county of Sauk on the first Monday in March and the Tuesday after the first Monday in September; in the county of Waushara on the second Monday in January and the first Monday in June.

SECTION 10. A judge for the twenty-fifth judicial circuit (which circuit is created by this act) shall be elected in the several election precincts of Columbia, Marquette, Sauk and Waushara counties on the first Tuesday of April 1962, in accordance with the laws relating to the election of circuit judges. The term of office of the judge chosen at such election shall commence on the first day of May 1962, and expire on the first Monday of January 1968. Thereafter, the term shall commence on the first Monday of January.

SECTION 11. Of this act, SECTIONS 1, 3, 4, 7, 8 and 10 shall take effect on July 1, 1961, and SECTIONS 2, 5, 6 and 9 shall take effect on May 1, 1962.
