Ind 69.20 Elevators, power dumbwaiters, escalators, moving walks, moving ramps and personnel hoists; plan examination and approvals. (1) Plans for elevators, power dumbwaiters, escalators, moving walks, moving ramps, and personnel hoists shall be submitted for each installation in compliance with Wis. Adm. Code section Ind 4.04, \checkmark (Elevators); and Wis. Adm. Code section Ind 44.01, \checkmark (Personnel Hoists).

(2) The plan examination and approval fee for each installation shall be assessed and collected as outlined in this subsection:

(2) Fees to be assessed and collected for shop inspections shall be as follows:

Ind 69.50 Certificates of competency. (1) Insurance company employes eligible in accordance with the provisions of the applicable administrative code, to be examined for competency as a boiler inspector or as an elevator inspector shall submit with the proper application forms an examination fee of \$25.00.

(a) An applicant who fails the scheduled examination may apply for re-examination, but no additional examination application fee shall apply provided the application is filed within 12 months from the date of the first examination.

(2) The commission may renew certificates of competency on an annual basis. The annual renewal fee shall be \$5.00.
