PSC 8.01 Forms. The forms named in this chapter are listed according to title, as provided for in section 227.013 (3), Wis. Stats., with such explanatory material as is additionally required for identification being given in editorial brackets.

PSC 8.02 Obtaining forms. Forms listed in this chapter may be obtained from the Public Service Commission, 450 Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin 53702, by utilities, motor carriers, railroads, or applicants in matters pertaining to motor carriers water powers, or navigable waters. Inquiries on obtaining forms should be addressed to the commission as shown above.

PSC 8.05 Motor carrier forms. (1) APPLICATIONS. (a) Application for common motor carrier certificate.

(b) Application for amendment to common motor carrier certificate.

(c) Application for approval of assignment of license or certificate.

(d) Application for contract motor carrier license.

(e) Application for amendment to contract motor carrier license.

(f) Prehearing instructions for applicants requesting contract motor carrier license and/or common motor carrier certificate and amendments thereto or requesting approval of complete or partial assignment of license or certificate.

(2) REPORTS. (a) Motor carrier annual report form A. [This is the Interstate Commerce Commission form for class I common and contract motor carriers of property. An insert form 4 MTD is added to provide Wisconsin data.]

(b) Motor carrier annual report form B. [This is the Interstate Commerce Commission form for class II common and contract carriers of property. An insert form 4 MTD is added to provide Wisconsin data.]

(c) Motor carrier annual report form D. [This is the Interstate Commerce Commission form for class I common and contract motor carriers of passengers. An insert form 3 MTD is added to provide Wisconsin data.]

(d) Annual report of common motor carriers, form 11 MTD. [This form is for all Wisconsin class III common motor carriers of property and all Wisconsin class II and III common motor carriers of passengers.]

(e) Quarterly report of revenues, expenses, and statistics, class I Motor Common Carriers of General Freight. [This is an Interstate

Commerce Commission form required of Wisconsin class I common motor carriers of property filing annual report form A listed in paragraph (a) of this subsection.]

(f) Quarterly report of revenues, expenses, and statistics, class II motor carriers of property. [This is an Interstate Commerce Commission form required of Wisconsin class II common motor carriers of property filing annual report form B listed in paragraph (b) of this subsection.]

(g) Quarterly report of revenues, expenses, and statistics, class I common motor carriers of passengers, form 8 MTD, for Wisconsin class I common motor carriers of passengers filing annual report form D listed in paragraph (c) of this subsection.

(h) Monthly report of bus transportation, form 35 MTD, providing for statement of revenue passengers carried, passenger revenues, bus miles, and ticket and token data; required of all common motor carriers of passengers holding intrastate authority.

PSC 8.06 Railroad reports. (1) ACCOUNTS AND OPERATION. (a) State Commission Form A, Annual Report class I railroads. [This is an interstate commerce commission form plus additional Wisconsin data on schedules No. 710, railway operating revenues earned within Wisconsin; No. 931, statistics of rail-line operations within Wisconsin; and No. 941, revenue freight carrier during the year in Wisconsin.]

(b) State Commission Form C, annual report of class II railroads. [This is an Interstate Commerce Commission form.]

(c) State Commission Form, Electric Annual Report—Electric Railways. [This is an Interstate Commerce Commission form.]

(d) State Commission Form, Express Annual Report—Express Companies. [This is an Interstate Commerce Commission form.]

(e) Quarterly report of revenues, expenses, and railway investment required of class II railroads.

(f) Quarterly report of freight commodity statistics [an Interstate Commerce Commission Statement required of class I railroads].

(g) Gross operating revenues derived from intrastate operations in the state of Wisconsin for calendar year 19—. Required of railroads as defined in section 195.02, Wis. Stats.

(h) Statement of highway crossing changes to the public service commission.

(2) **ACCIDENT REPORTS. (a)** Form L, monthly report of accidents on electric railways.

(b) Form T, monthly report of railway accidents.

(c) Form V, monthly report of railway accidents [summary of separate reports made in paragraph (b) above].

(d) Monthly report of railway accidents—subsequent fatalities.

PSC 8.10 Water powers; application forms. (1) Application for approval of the placing of sand or other similar material on bed of lake (section 30.12 (2) (b), Wis. Stats.).

(2) Application for permit to divert water for irrigation under section 30.18, Wis. Stats.

(3) (a) Application for a contract to remove materials from the beds of natural navigable waters where the State of Wisconsin has ownership in the area of the bed of which the material is to be removed under the trust doctrine, listing those facts which are necessary before the commission can determine whether the requirements of section 30.20, Wis. Stats., will be met.

(b) Application for a permit to remove materials from the beds of navigable waters where the State of Wisconsin does not have ownership in the area of the bed of which the material is to be removed, listing those facts which are necessary before the commission can determine whether the requirements of section 30.20, Wis. Stats., will be met.

(4) Application for a permit to construct, operate, and maintain a dam in a navigable stream. (sections 31.05, 31.06, 31.09 and 31.12, Wis. Stats.)

(5) Application for permit to abandon dams—section 31.185, Wis. Stats.

(6) Application for permit to transfer ownership of dam—section 31.185, Wis. Stats.
