VE 2.01 Definition, "Board" means the veterinary examining board.

VE 2.03 Educational qualifications. Applicants for license shall submit proof of graduation from an approved school of veterinary medicine. Schools in the United States and Canada, approved by the American veterinary medical association are approved by the board. Graduates of schools outside the United States and Canada are required to complete the educational commission for foreign veterinary graduates certification program of the American veterinary medical association as a pre-requisite to eligibility for examination. The educational commission for foreign veterinary graduates certificate shall accompany the application for examination. Temporary permits may be issued by the board but only to graduates of schools in the United States and Canada.

VE 2.04 License; application. Application for license shall be made on forms prescribed by the board and shall be accompanied by the examination fee. Should the applicant not take the next examination, after notification that the applicant has been accepted, applicant must reapply in order to qualify for the next examination.

- VE 2.05 License; fee, renewal, display thereof, change of address.

 (1) No license shall be renewed except upon payment of the biennial fee.
- (2) The license and renewal shall be displayed in an area open to the public in the place of practice.
- (3) Veterinarians shall notify the board of any change in their practice address within 30 days of such change.

VE 2.08 Temporary permit. (1) A graduate of a veterinary college approved by the board who meets all requirements for examination may be granted a temporary permit to practice veterinary medicine until the results of the next examination are known provided the applicant is employed and supervised by a licensed veterinarian. Applicants for such temporary permit must provide prior to appearance before the board:

- (b) Permit fee of \$10.00.
- (2) The applicant must personally appear before the board and satisfactorily answer an oral examination by 3 of 4 examining board members in order to obtain a temporary permit. If the applicant does not answer 3 or more examinations satisfactorily, the applicant may be re-examined at the next regularly-scheduled board meeting without paying an additional fee.
 - (3) A temporary permit shall expire upon:
 - (a) Failure of the examination.
- (b) Failure to apply for and to take the next scheduled licensing examination.
