(1) The open seasons specified in the following table apply to fishing in open waters and fishing through the ice, except that the department shall close the season for fishing through the ice in any inland waters when it finds after scientific investigation and study that continued fishing through the ice in such waters would result in a depletion of the supply of game fish therein and that such closed season is necessary to conserve the fish supply and insure the citizens of this state continued opportunities for good fishing therein and such closed seasons shall be put into effect by posting a notice thereof on or in the vicinity of the shore of the waters affected, such posting being deemed by the department to be the most feasible way of notifying the public that such closed season is in effect and such closed seasons shall remain in full force and effect so long as such waters are covered with ice and so long as such posting is continued. The possession limit for each species of fish shall be double the daily bag limit specified in this chapter except that no person shall have in his possession or under his control more than the daily bag limit while on the ice or waters or while fishing in the state of Wisconsin. The measurement of all fish taken shall be in a straight line from the tip of the snout to the utmost end of the tail fin fully extended.

NR 20.05 Season for crayfish and frogs. (1) CRAVFISH. There is no closed season on crayfish or crabs in the inland waters except in Manitowoo county where there is a closed season from March 1 to but not including the Saturday nearest June 15.

(2) METHOD OF TAKING. Crayfish or crabs may be taken in the following ways; by hand, minnow seines, minnow dip nets and minnow traps where the same are permitted for the taking of minnows (see minnow regulations, section NR 20.10) and by crab traps with the entrance of the trap not to exceed 2½ inches at greatest diagonal measurement. Each such trap shall have securely attached to it a label or tag clearly Register, October, 1980, No. 298 bearing in the English language the name and address of the operator. All such traps shall be raised and the crayfish or crabs removed therefrom at least once in every 24 hours.

(3) FROGS. (a) The open season for taking, killing or capturing frogs shall be from the Saturday nearest May 1 to December 31.
