History: Chapter Ag 5 as it existed on April 30, 1976 was repealed and a new chapter Ag 5 was created effective May 1, 1976.

- Ag 5.01 Premiums and exhibits. (1) Premium LISTS. (a) Premiums for which state aid is requested by county and district fairs shall be in strict conformity with uniform premium lists and other requirements as prescribed in these rules. Fairs requesting state aid for net premiums shall submit to the department, 30 days prior to the opening of the fair, a printed copy of the premium list to be used at the fair.
- (b) The officers of each fair shall mail a copy of the premium list to other associations, societies, or boards conducting a fair in Wisconsin when a copy is requested by them.
- (c) Sections Ag 5.01, 5.02 and 5.07 Wis. Adm. Code shall be published in premium books to be used at a fair for which state aid is requested.
- (2) Entry fees. (a) Entry fees may be charged not in excess of 10% of the purse offered on any specific article. When no entry fee is charged, stall rents may be charged in the horse, cattle, sheep and swine departments. In the horse department the rental shall not exceed \$1.50 per single stall, and \$3 for box stalls; in the cattle department \$1 for single stalls, and \$2 per box stall; in swine and sheep departments \$2 per pen or 50 cents per animal. A standard pen is approximately 64 square feet. In the poultry, rabbit and pet stock department the charge shall not exceed 25 cents per head.
- (b) Exhibitors in educational and school departments shall not be required to purchase exhibitors' tickets. Other exhibitors may be required, when no entry fee is charged, to purchase an exhibitors' season ticket at a price not to exceed that charged for non-exhibitors' season tickets.
- (c) Exhibitors shall not be required to become members of the fair society, or be required to make any donations or refunds to the society.
- (3) EXHIBITS AND EXHIBITORS. (a) State aid may not be approved for out-of-state exhibits or for separate classes of local and non-local exhibitors. Aids may not be approved for payment of premiums to Wisconsin residents with out-of-state addresses unless the fair secretary provides the department with an affidavit that such exhibitors reside in Wisconsin.
- (b) State aid may be paid only on articles or animals actually on display in exhibit buildings or actually shown in the show ring during the regular fair dates except as split dates are provided for under sub. (6).

State aid will not be paid on D.H.I.A. records, transportation aids, production contests, or the like, unless special approval is granted under section Ag 5.02 (8), Wis. Adm. Code.

- (c) State aid may not be paid on exhibits removed from the fair-grounds before 4 p.m. of the last day of the fair, or such other later time as may be specified by the fair, without prior approval of the department. Authority for earlier removal may be granted by the department in the case of meat animal sales or other special classes, if requested before the beginning of the fair. In other hardship cases, approval may be granted by the local fair. Exhibits in dog obedience and small animal pet classes shall be judged during the regular fair but are not required to remain present during the entire fair. The local fair may prescribe the length of time horses shall remain on the grounds for junior exhibitors.
- (4) JUNIOR FAIRS. (a) In the junior fair division, state aid will be paid on prizes offered to exhibitors who are 8 through 19 years of age. On January 1 of the current fair year except exhibitors under section Ag 5.06 (35) Wis. Adm. Code may be pupils of school age as defined in s. 118.14, Stats. State aid will not be paid on prizes for club parades, club floats, song contests, or any project which is not an exhibit or demonstration at the fair.
- (b) All exhibitors in the junior fair division shall be members of 4-H, FFA, FHA, or any other recognized youth organization under adult leadership and with an education program approved by the local fair.
- (c) Exhibits in the junior fair shall be a result of the exhibitor's own labor in the project or projects in which he or she is regularly enrolled.
- (d) Premiums in the educational department shall be paid directly to the exhibitor making the exhibit and not to the school or teacher, except for group premiums offered to interschool competitive classes. A complete list of exhibitors and a complete set of judges' sheets for the education department, similar to those required in other departments, shall be filed with the department. No aid may be paid on education department premiums unless this is done. All educational exhibits shall be on display at the fair even though they are judged prior to the fair.
- (e) State aid may be used for the payment of no more than one premium awarded an exhibitor under any one premium or lot number in the junior fair division, except when awarded as a part of a group in livestock exhibits or in showmanship.
- (f) Junior fair exhibitors may receive state aid premiums on articles or animals at only one county or district fair and may not receive state aid premiums in the same department at any other fair.
- (5) Premiums. (a) The state aid authorized by s. 93.23 (1), Stats., may be paid on net premiums only. Net premiums shall be construed to mean the total premiums paid less total entry fees received. State aid will be paid only on premiums actually paid by bank check or draft.
- (b) No deductions may be made from premium money won by an exhibitor. Premiums may, however, be withheld where exhibition rules established by the fair association are violated. A written statement of violation shall be submitted to the department to justify action taken by the local fair.

- (c) Premiums offered shall be definite in amount. No decrease or increase in published premiums may be made because of the financial condition of the organization or for any other reason.
- (d) State aid may be paid on no more than 2 premiums awarded an exhibitor under one premium or lot number in open class individual livestock classes, and no more than one premium in other classes.
- (e) To be eligible for state aid, no animal or article shall be entered in competition for more than one premium, except as part of a herd group, carcass class, or a performance class.
- (f) No state aid will be paid on the cost of ribbons, cups, trophy prizes or entertainment contests.
- (6) Dates. No state aid may be paid to fairs having split dates, unless prior written approval is granted by the department. Extreme hardship must be established by the fair organization before approval can be granted. A split date is one where exhibits or contests are judged, and premiums paid at more than one time or at more than one location during the current year. When split dates are approved, all blue ribbon winners shall be required to repeat their demonstration or exhibit at the regular fair dates, unless exempted by the department in hardship cases. Split date approval shall not be required for dress revue, demonstration, or favorite foods revue.

- Ag 5.02 Classes; general. (1) In all prescribed departments, special classes may be established for any item, article, or recognized breed (eligible for registry), where none are specified, including special classes for grade (not eligible for registry) and crossbred females in beef, swine, and sheep in the junior fair division. State aid, in amounts prescribed, may be paid for such special classes.
- (2) Classes may be combined, but state aid shall be limited to maximum premiums listed for a single class of such animals, items, or articles.
- (3) No state aid may be paid on premiums awarded for any dairy cattle, beef cattle, sheep, goats, swine or horses of the male sex (other than those which have been desexualized) exhibited in any class unless the animal is registered or eligible for registry.
- (4) Animals entered in group classes shall also be exhibited in a class for individual animals.
- (5) State aid for premiums awarded for horses in open classes shall be limited to horses which are owned by the exhibitor.
- (6) The total of maximum premiums prescribed for the places in any open class of livestock, (excluding poultry and rabbits) may be divided into premiums for a greater number of places but the maximum premium for any additional place shall not be higher than the maximum prescribed for the last place in such class.
- (7) If 16 or more animals, items or articles are entered in any junior fair class, at the discretion of the fair, the class may be divided into 2 or more approximately equal groups according to weight, age or other identification and each group judged as a class.

- (8) Special educational exhibits may be instituted if presented to the Wisconsin association of fairs prior to October 1 of the year preceding the fair year, and such exhibits approved by the department of agriculture.
- (9) In the swine departments, mature boars may not be entered unless their tusks have been removed.
- (10) All animals in the open class shall be owned by the exhibitor except as provided in section 5.03 (2), Wis. Adm. Code.

- Ag 5.03 Definitions; class requirements. (1) Individual classes. (a) Dairy cattle. 1. A junior calf is one born on or after January 1 of exhibit year. The calf shall be at least 4 months old at the time of exhibit.
- 2. A senior calf is one born during the period July 1 to December 31 of the year preceding exhibit year.
- 3. A junior yearling is one born during the period January 1 to June 30 of year preceding exhibit year.
- 4. A senior yearling is one born during the period July 1 to December 31 of second year preceding exhibit year. If senior yearling has calved, it shall be shown in 2-year-old class.
- 5. A 2-year-old is one born during the period July 1 of third year preceding exhibit year to June 30 of second year preceding exhibit year, and shall include senior yearlings which have freshened.
- 6. A 3-year-old is one born during the period July 1 of fourth year preceding exhibit year to June 30 of third year preceding exhibit year.
- 7. A 4-year-old is one born during the period July 1 of fifth year preceding exhibit year to June 30 of fourth year preceding exhibit year.
- 8. A 5-year-old is one born before July 1 of fifth year preceding exhibit year.
- 9. A dry cow is one not less than 3 years old which is not currently lactating, but has milked 280 days or more since the last fair season.
- (b) Beef cattle. 1. A junior calf is one born on or after January 1 of exhibit year. The calf shall be at least 4 months old at the time of exhibit.
- 2. A senior calf is one born during the period September 1 to December 31 of year preceding exhibit year.
- 3. A summer yearling is one born during the period May 1 to August 31 of year preceding exhibit year.
- 4. A junior yearling is one born during the period January 1 to April 30 of year preceding exhibit year.
- 5. A senior yearling is one born during the period September 1 to December 31 of second year preceding exhibit year.
- 6. A 2-year-old or older cow is one born before September 1 of second year preceding exhibit year and which has calved during the past year.

- (c) Steers. 1. A senior calf is one born during the period September 1 to December 31 of the year preceding exhibit year.
- 2. A summer yearling is one born during the period May 1 to August 31 of year preceding exhibit year, and which has all milk teeth in place.
- 3. A junior yearling is one born during period January 1 to April 30 of year preceding exhibit year, and which has all milk teeth in solidly and shows no nicking at gums.
- (d) Swine. 1. A junior yearling boar or sow is one born during the period January 1 to June 30 of year preceding exhibit year.
- 2. A senior boar or sow is one born during the period of the July 1 of the year preceding exhibit year to December 31 of the year preceding exhibit year.
- 3. A senior spring boar or sow pig is one born during the period of January 1 to the last day of February of the exhibit year.
- 4. A junior spring boar or sow pig is one born during the period March 1 to June 30 of exhibit year.
- (e) Sheep. 1. A spring lamb for the Cheviot, Southdown, Shropshire, Columbia or Oxford breeds is one born on or after February 1st of the exhibit year. For all other breeds, a spring lamb is one born on or after December 15th of the year preceding exhibit year.
- 2. A fall lamb for the Cheviot, Southdown, Shropshire, Columbia or Oxford breeds is one born during the period between September 1 of the preceding exhibit year through January 31st of the exhibit year. For all other breeds, a fall lamb is one born during the period between September 1 through December 14th of the year preceding exhibit year.
- 3. A mature ram or ewe is one born before January 1 of the year preceding exhibit year.
- 4. A yearling ram or ewe is one born outside the date of birth limitations in subd. 1, 2 and 3. The age of yearlings may be subject to verification by a veterinarian's examination whose findings shall be final.
 - 5. A market lamb is one born after January 1 of the exhibit year.
- (f) Goats. 1. In the open class division, age shall be determined as of the opening date of the fair and the following age classifications shall apply:
- a. Does under 24 months of age that have never freshened may only compete in the junior age classification.
- b. Does 24 months of age or over that have never freshened may not be shown.
- c. Does that have freshened at least once, including dry milkers, may only compete in the senior age classification.
 - d. A milking yearling is under 2 years old.
 - e. A 2 year old is over 2 and under 3 years of age.
 - f. A 3-5 year old is over 3 and under 5 years of age.
 - g. An aged doe is over 5 years of age.

- 2. In the junior fair division the following age classifications shall apply:
 - a. A junior kid is one born on or after April 1 of exhibit year,
- b. A senior kid is one born during the period between January 1 to March 31 of the exhibit year.
- c. A junior yearling is one born during the period between July 1 to December 31 of the year preceding exhibit year.
- d. A senior yearling is a dry doe born before July 1 of the year preceding exhibit year but less than 24 months of age.
 - 3. Male goats and goats with full natural horns may not be entered.
- (g) Poultry. 1. Cock and hen birds are birds hatched before January 1 of the exhibit year.
- 2. Cockerel and pullet birds are birds hatched on or after January 1 of exhibit year.
- (2) Group classes. (a) Dairy and beef cattle. 1. A dairy junior get of sire shall consist of 3 animals which are the offspring of the same bull. All of these animals shall be under 2 years of age, and not more than one can be a bull. A beef junior get of sire shall consist of 3 animals which are the offspring of the same bull from junior calf, senior calf, and/or summer yearling, bull and heifer classes, with both sexes to be represented.
- 2. A dairy senior get of sire shall consist of 3 animals which are the offspring of one shire. All of these animals shall be 2 years of age or over, and not more than one may be a bull. A beef senior get of sire shall consist of 4 animals, any age, the offspring of one sire, both sexes to be represented. In both dairy and beef gets of sire, the name of the sire shall be designated by the exhibitor. The animals need not be owned by a single exhibitor.
- 3. A produce of dam shall consist of 2 animals, any age and any sex which are the produce of one cow.
- 4. A group of 3 best female cattle shall consist of 3 animals, any age, bred and owned by the exhibitor.
- (b) Swine. 1. A pen of market pigs shall consist of 2 animals (no boars).
- 2. A pen of 3 feeder pigs, 40 to 60 pounds each, may consist of either sex. If male pigs are included, they shall be castrated and healed.
- (c) Sheep. 1. A get of sire shall consist of 4 lambs or yearlings, or both, of either sex from one sire, bred and owned by the exhibitor.
- 2. An exhibitor's flock shall consist of one yearling or ram lamb, 2 yearling ewes and 2 ewe lambs owned by the exhibitor.
- 3. A junior division pair of lambs may include a spring or fall ram and a spring or fall ewe lamb owned by the exhibitor.
- 4. A junior division flock shall consist of 3 animals: a ram (yearling or lamb); an ewe lamb; and a yearling ewe owned by the exhibitor.
- A pen of market lambs shall consist of 2 market lambs owned by the exhibitor.

- (d) Goats. 1. An exhibitor's herd shall consist of one doe under one year, one yearling doe, and one doe 2 years or older, all owned by the same exhibitor.
- 2. A senior get of sire shall consist of 3 does which are the get of one sire, with at least one in milk. The animals need not be owned by a single exhibitor.
- 3. A junior get of sire shall consist of three does under 2 years that have never freshened and are the get of one sire. The animals shall be owned by a single exhibitor.
- 4. A produce of dam shall consist of 2 does of any age which are the produce of one doe. The animals shall be owned by a single exhibitor.
- (3) GENERAL DEFINITIONS. As used herein, unless the context otherwise requires:
- (a) "Department" as it relates to the organization or structure of fairs, means an animal species, production group or other principal subdivision of a fair. As used elsewhere, it means the state of Wisconsin department of agriculture.
- (b) "Division" means an age group classification within a fair department; for example, junior, open class or senior citizens.
- (c) "Class" means a breed, type of produce, crop or food, a specific age or educational grade group in which exhibits may be entered.
- (d) "Lot" means a specific age or sex grouping of animals, crop variety or style of exhibit.

- Ag 5.07 Judging regulations. (1) Judging shall be done at county and district fairs by individuals who are registered with the department and who have knowledge, training or experience in the specific class or classes to be judged as determined by the department. Judging shall be done in accordance with the requirements of section Ag 5.08 (3) (a), Wis. Adm. Code. In no case shall any person who is an officer or director of a fair be eligible to judge exhibits at such fair; nor shall any person interested directly or indirectly in exhibits shown in any department of a fair be eligible to judge articles or animals in that department.
- (2) Each judge shall be provided with a copy of the premium book at least 7 days prior to the opening date of the fair at which he or she shall act as a judge.
- (3) No animal or article, irrespective of the number of entries in the class in which it is entered, shall be awarded a higher rating than its merit would entitle it to in comparison to the standard of perfection in the class.
- (4) (a) No state aid will be paid on premiums awarded under the Danish system in any classes except in the junior and educational departments.
- (b) When classes in the junior and educational departments are judged according to the Danish system, 4 group placings shall be awarded in any class. When there are less than 8 exhibitors in the class, there shall not be more than 2 in the first group, not more than 4 in the first 2 groups and not more than 6 in the first 3 groups. If there are 8 or more entries in the class, there shall not be more than 25% in the first group, not more than 50% in the first 2 groups, and not more than 75% in the first 3 groups.
- (c) The number of awards in the last group placing may be increased to the extent necessary to give awards to all exhibitors.

- Ag 5.08 Accounting requirements. (1) All receipts from any source whatsoever shall be deposited in a bank, and all accounts without exception shall be paid by check or draft. All records, papers, stubs, checks, vouchers or other orders relating to fair transactions shall be preserved for a 6-year period subsequent to the year in which they were made or issued.
- (2) Premiums shall be actually paid or bona fide notice of premium awards sent to all premium winners before a claim for state aid may be considered.
- (3) Claims for state aid shall be filed with the department within 30 days after the close of the fair, and shall include:
- (a) Judging sheets completed according to instructions contained thereon. All entries shall be in typewritten form with the exception of entries in the winning entry column which may be made with a ballpoint pen or indelible pencil. The total premium awarded on each judging sheet shall be shown at the bottom of each sheet. State aid shall not be

paid on judging sheets which are not signed by the judge or accompanied by an affidavit of the judge listing the department and classes judged. A separate affidavit shall be required for each department.

- (b) Index of exhibitors and their addresses, with amounts paid in premiums opposite each name. The total of each index sheet shall be shown on the bottom of the sheet, and the total of the index shall correspond with the total of premiums awarded as shown by judging sheets.
 - (c) One youcher claim for state aid.
 - (d) One premium book.
- (4) One copy of the annual financial report shall reach the office of the department before the end of the calendar year in which the fair is held. State aid received for the current year shall be included as a receipt in such statement.
- (5) Before submitting its financial report, every fair association, society or board shall have its accounts audited by either a certified public accountant, a county auditor, or an auditing committee. If audited by an auditing committee, at least one of the committee members shall be familiar with the records and procedures. The society or board shall submit to the department at the time the financial report is submitted, a statement of the type of audit conducted including the date and names of those making the audit, or a copy of the audit report.
- (6) A copy of a financial report as published in a newspaper of general circulation in the county in which the fair was held shall be submitted to the department prior to December 31st of the year in which the fair was held. The financial statement shall include all receipts, disbursements, accounts receivable and accounts payable in connection with the operation of the fair, and shall show the financial condition of the fair organization before and after the fair.
