NR 33.01 Scope of chapter. The rules in this chapter are made under s. 70.335 (17), Stats. and apply to lands managed pursuant to s. 70.335, Stats.

- NR 33.02 Cutting notice. (1) No timber shall be cut on any sustained yield forest land unless the owner has first filed a cutting notice with the department.
- (2) No cutting shall be done until 15 days after the filing of the cutting notice unless prior approval to cut has been received from the department.
- (3) No cutting shall be done on any land description on which approval of the department is withheld until such time as the reasons for withholding of approval are discussed and resolved between the owner and the department. Notice that approval is withheld shall be given in writing to the owner within 15 days from the date the cutting notice is filed with the department and shall be only for silvicultural purposes and in accordance with the forest management plan. A meeting to discuss the reason or reasons for withholding of approval shall be held at the request of the owner, within 15 days from the date that such withholding of approval is given.
- (4) All timber intended to be cut on a given tract under such cutting notice shall be marked or designated by the owner in accordance with the approved forest management plan prior to filing such cutting notice.
- (5) Such cutting notice shall be given on Form FT-1 entitled "Cutting Notice of Timber Marked or Designated for Cutting from Sustained Yield Forest Land" on file with the revisor of statutes. Such forms may be obtained from the department's forester for Menominee county.

NR 33.03 Timber scale. The Scribner Decimal C log rule shall be used in log scaling on sustained yield forest lands.

NR 33.04 Withdrawal of lands. (1) Any owner of sustained yield forest lands who intends to withdraw any parcel of such land not more than 10 acres in size, pursuant to s. 70.335 (11), Stats., shall give notice of such withdrawal to the department of natural resources and to the secretary of revenue on form FT-2 entitled "Notice of Withdrawal—Ten

Acres or Less" on file with the revisor of statutes. Such forms may be obtained from the department's forester for Menominee county.

(2) Any owner of sustained yield forest lands who intends to withdraw any parcel of land larger than 10 acres in size or any withdrawal which results in a cumulative total of more than 250 acres withdrawn in one calendar year, pursuant to s. 70.335 (12), Stats., shall file an application for withdrawal with the secretary of revenue on form FT-3 entitled "Application for Withdrawal" on file with the revisor of statutes. Such forms may be obtained from the department's forester for Menominee county.

NR 33.05 Reentry of land. Any owner who wishes to reenter lands previously entered as sustained yield forest lands pursuant to s. 70.335 (13), Stats., shall file an application for reentry with the department of natural resources and the secretary of revenue on form FT-4 entitled "Application for Reentry" on file with the revisor of statutes. Such forms may be obtained from the department's forester for Menominee county.

NR 33.06 Transfer of ownership. Any owner of sustained yield forest lands who conveys any of such lands shall file a notice of transfer of ownership not later than 60 days prior to the date of conveyance with the secretary of revenue and the department of natural resources on form FT-5 entitled "Notice of Transfer of Ownership" on file with the revisor of statutes. Such forms may be obtained from the department's forester for Menominee county.
