## A-E 3.10 Rules committee

**History:** Chapter A-E 3 as it existed on December 31, 1973 was repealed and a new chapter A-E 3 was created effective January 1, 1974.

**A-E 3.10 Rules committee. (1) COMPOSITION.** The rules committee of the examining board of architects, professional engineers, designers and land surveyors shall be comprised of one member from each section and 2 public members from any 2 of the 4 sections appointed by the chairperson of the board.

**(2) AUTHORITY AND RESPONSIBILITY.** The rules committee shall act for the board in rulemaking proceedings except for final approval and adoption of administrative rules.
