## (Section 29.174, Wis. Stats.)

**WCD 11.01 Complete protection.** It shall be unlawful for any person to take, catch, kill, hunt, trap, or pursue in any manner any species of wild animals or birds at any time on the following described areas:

(1) CHIPPEWA COUNTY. (a) *Fisher river.*

Township 31 north, range 6 west, towns of Estella and Holcombe.

Section 4—All that part lying west and south of town road running diagonally through SW SW of said section.

Section 5—All that part lying south of town road running generally east and west through said section.

Section 6—All that part lying south and east of the Chippewa river and south of a straight east-west line extending from the west end of the town road described in section 5 to the east bank of the Chippewa river.

Section 7—All that part lying east of a line formed by the Chippewa river and the Brunet Island park road including the mouth of the Fisher river.

Section 8—Entire section.

Section 9—All that part lying north and west of town road running diagonally through NW  $\frac{1}{4}$  of said section.

(2) COLUMBIA COUNTY. (a) *Indian Agency house.*

Township 13 north, range 9 east, town of Fort Winnebago.

Section 33—Government Lot 7. City of Portage—Outlots 7, 8, 9, and 10.

(3) DANE COUNTY. (b) *University of Wisconsin arboretum.*

Sections 8 and 9—Entire sections.  
Section 16—Entire section except that part lying south of Windsor Dam road.

Section 17—Entire section except those parts lying south of Windsor dam road.

Section 20—All that part lying north of Windsor Dam road.

(5) ONEIDA COUNTY. (a) *American Legion rest camp.*  
Township 38 north, range 7 east, town of Lake Tomahawk.  
Section 8—Government Lots 3, 4, and all that part of Government Lot 6 lying south and east of a road running northeasterly from the northwest corner of McGrath lake to Little Tomahawk lake.

**WCD 11.02 Closed area; waterfowl project.** It shall be unlawful for any person to take, catch, kill, hunt or pursue with the use of firearms or bow and arrow any species of wild animals or birds at any time on the following described areas and no person shall carry any firearm or bow while being in, on or traversing such area unless the same is unloaded or unstrung and enclosed within a carrying case:

(1) BROWN COUNTY. (a) *Preble.*

Township 23 north, range 21 east, town of Preble.

Section 4—W $\frac{3}{4}$ .

Section 5—Entire section except that part lying south of county highway "V".

Section 6—All that part lying east of county highway "XX".

Sections 7 and 8—All that part of the town of Preble lying between county highway "XX" and U. S. highway 141.

Township 24 north, range 21 east, town of Preble.

Sections 29 and 30—All that part lying south and east of the city limits of Green Bay.

Section 32—Entire section.

**WCD 11.03 Closed area; pheasants.** It shall be unlawful for any person to take, catch, kill, hunt, trap, or pursue in any manner any species of wild animals or birds at any time on the following described areas, and no person shall carry any firearms or bow while being in, on or traversing such area unless the same is unloaded or unstrung and enclosed within a carrying case:

(1) **DODGE COUNTY.** (a) *Neosho.*

**WCD 11.04 Closed area; deer.** It shall be unlawful for any person to take, catch, kill, hunt, or pursue with the use of any rifle other than a .22 rim fire, shotguns loaded with single slug or ball, or bow and arrow any species of wild animals or birds at any time on the following described areas:

(1) **ASHLAND COUNTY.** (a) *La Pointe.*

Township 50 north, range 3 west, Madeline island.

All that part of section 30 bounded by the following description: Beginning at a point on the lake shore 200 yards south of the La Pointe ferry dock and opposite the point where the southern route of county highway "H" turns ENE and proceeding for 250 yards on county highway "H" to a town road; proceed north on said town road to its junction with the northern route of county highway "H"; thence in a southwesterly direction on county highway "H" for a distance of 340 yards to the junction of a town road; proceed due north on said town road until directly east of Pt. DeFroid; proceed west from this point on a town road to the lake shore; thence south-erly along lake shore to point of beginning.

(2) **BAYFIELD COUNTY.** (a) *Eau Claire lakes.*

Section 8—All that part lying north and west of Emily lake town road.

(b) *Spread Eagle.*

Township 39 north, range 19 east, town of Florence.

Section 2—All that part lying south of Menominee river.
