WGC 16.01 Purpose. The purpose of this chapter is to establish rules which identify prohibited activities of employes of licensees.

WGC 16.02 Definitions. (1) "Touting" means the act of soliciting anything of value in exchange for information regarding the outcome of a race conducted at a pari–mutuel race meeting under the jurisdiction of the commission.

- **(2)** "Bookmaking" means the act of accepting a wager from a patron of a pari–mutuel race meeting with the intent to withhold the wager from the pari–mutuel pool.
- **(3)** "Theft" means the act of knowingly exerting control over state revenue or the revenue of a racing association or, by deception, obtaining control over patron dollars.

WGC 16.03 Employes of class A, B or C licensees.

(1) WAGERING. No employe of any person licensed pursuant to s. 562.05 (1) (a), (b) or (c), Stats., shall place any wagers, or cause any wager to be placed, directly or indirectly, on any race during

the time he or she is working. Any employe shall be deemed to be working from the start of their shift until the end of the shift, and may not wager during breaks, lunch or any other time before they are discharged from their duties that day. No employe may wager while wearing any clothing or other identification that indicates they are an employe of a licensee. No racing official employed by any person licensed pursuant to s. 562.05 (1) (a), (b) or (c), Stats., may place any wager, directly or indirectly, at any track under the jurisdiction of the commission.

- **(2)** THEFT. No employe of any person licensed pursuant to s. 562.05 (1) (a), (b) or (c), Stats., shall commit theft.
- (3) TOUTING AND BOOKMAKING. No person shall engage in touting or bookmaking.

WGC 16.04 Occupation licensees. Occupation licensees having immediate care and custody of an animal may only wager on a race in which this animal is entered if the wager includes this animal. No occupational licensee having immediate care and custody of more than one animal in a race may wager on that race. No lead—outs may wager on any race at the race meeting in which they are participating.
