PI 4.01 Salary schedule for county supervising teachers. Section 39.20 (7), Wis. Stats. With prescribed limits.

(2) The placement on the county supervising teacher salary schedule of county supervising teachers employed during the 1960-61 school year shall be as follows:

(a) A county supervising teacher with four years of training shall qualify for salary schedule benefits as listed in column (a).

(b) A county supervising teacher previously placed on a schedule with five years of training shall qualify for salary schedule benefits as listed in column (c).

(c) A county supervising teacher previously placed on a schedule with a semester beyond the master's degree shall qualify for salary schedule benefits as listed in column (d).

(d) A county supervising teacher previously placed on a schedule with six years of training shall qualify for salary schedule benefits as listed in column (e).

(3) Any supervising teacher not employed as a county supervising teacher in the 1960-61 school year shall meet the experience and training requirements set forth in the county supervising teacher salary schedule under subsection PI 4.01 (1).

(4) Proof of professional preparation and qualifying experience shall be certified to the state superintendent by the supervising teachers before August 15 or within 10 days of employment.

(5) The following schedule shall be used to determine "years of experience credit" on the salary schedule:

(a) One year of credit shall be given on the salary schedule for each year of experience as a county supervising teacher.

(b) One-half year of credit shall be given for each year of experience as a teacher. The maximum number of years of credit for experience on the schedule under (5) (b) cannot exceed 5 years; major fractions shall be counted as the next whole year; experience credit shall be determined at the beginning of employment for each school year.

(c) One year of credit shall be given for each year of experience as a county superintendent, city supervisor or as supervisor in a district employing 20 or more teachers or as an administrator of a school system with 20 or more teachers. The maximum number of years of credit for experience on the salary schedule under (5) (c) shall not exceed 7 years.

(6) Rating on the salary schedule shall be made by the state superintendent by August 15 or within 10 days of receipt of certification if employed after August 15. Advancement on the schedule shall be based upon certification of evidence submitted to the state superintendent.

PI 4.02 Expense. Section 39.20 (2), Wis. Stats. (1) Whenever the duties require the supervising teacher to travel outside the municipality in which the county office is located, the state will reimburse for reasonable meal expenses.

(2) Actual and necessary expenses shall include actual expenses incurred in the regular performance of duty as a supervisor under the direction of the county superintendent, in attending the institutes and conferences called by the state superintendent of schools and in attending special regional conferences for county supervisors under the direction of the state supervisors as authorized by the state superintendent of schools.

(3) Mileage, travel, lodging and other approved necessary expenses shall be reimbursable on the basis of the amount actually paid by the county.

PI 4.05 Specialists and additional supervisors. Section 39.20 (1) (c) Wis. Stats. (1) The official responsibility of the state superintendent to approve qualifications of supervising teachers and specialists pertains only to those individuals hired pursuant or reported pursuant to the effective date of chapter 367. (July 5, 1953)

(2) For the approval of qualifications, specialists and supervising teachers (beyond the statutory number) would be divided into these classifications, each possessing the qualifications listed:

(a) *Special state aid reimbursement fields of education*—the qualifications required would be those required by statute for teaching in the special fields (speech correction, mentally retarded, etc.).

(b) *Subject matter supervisors or specialists*—the qualifications required: Wisconsin certification for teaching in the subject matter field (physical education, music, art, etc.).

(c) *Non-subject matter*—the qualifications required: Wisconsin certification as a teacher plus two years of successful related teaching experience (transportation, etc.).

(d) *Other professional workers*—the qualifications required: such training and/or experience as will qualify them for membership in their own national organization (social workers, etc.) such qualifications to be superseded by certification standards when such standards are approved by the department of public instruction.

PI 4.06 Salary schedule for county superintendents. Section 39.06 (6) and (7), Wis. Stats. (1) With prescribed limits.

(2) The above salary schedule for county superintendents represents the county supervising teacher salary schedule subsection PI 4.01 (1) adjusted to comply with subsection 39.06 (6), Wis. Stats.

(3) Each county superintendent shall qualify for placement upon the salary schedule as set forth in subsection PI 4.06 (1).

(4) Proof of professional preparation and qualifying experience shall be certified to the state superintendent by the county superintendent before July 1 or within 10 days of employment.

(5) The determination of the "year of experience credit" on the salary schedule shall be based upon subsections PI 4.01 (a), (b) and (c).

(6) Ratings on the salary schedule shall be made by the state superintendent by July 1, or within 10 days of receipt of certification if employed after July 1. Advancement on the schedule shall be based upon certification of evidence submitted to the state superintendent.

(7) A county superintendent with 15 or more years of experience as a county superintendent as of July 1, 1961 and who does not hold a bachelor's degree shall qualify for salary benefits as listed in column (a).

(8) A county superintendent with less than 15 years of experience as a county superintendent as of July 1, 1961 and who does not hold a bachelor's degree shall qualify on 1st year line of experience in column (a).
