	appropriation".
3	<b>2.</b> Page 3, line 1: before that line insert:
4	"SECTION 1g. 20.005 (3) (schedule) of the statutes: at the appropriate place,
5	insert the following amounts for the purposes indicated:

9	(f) Prosecution cost payments GPR A 951,200 951,200
10	<b>SECTION 1m.</b> 20.455 (1) (f) of the statutes is created to read:

12	reimburse counties for domestic abuse incident prosecution costs under s. 968.075
13	(10).".
14	<b>3.</b> Page 3, line 1: delete "SECTION 1." and substitute "SECTION 1r.".

2	"SECTION 41m. 968.075 (10) of the statutes is created to read:
3	968.075 (10) REIMBURSEMENT. (a) The department of justice shall reimburse
4	counties for costs incurred in prosecuting cases involving domestic abuse incidents
5	up to the following total amounts:
6	1. All counties having a population of 500,000 or more, \$351,200 in each fiscal
7	year.
8	2. All counties having a population of less than 500,000, \$600,000 in each fiscal
9	year.
10	(b) If in any fiscal year the amounts under par. (a) are insufficient to completely
11	reimburse all applicable counties, the department shall prorate the payments.
12	(c) The department shall make reimbursement payments under this section
13	from the appropriation under s. 20.455 (1) (f).".
14	<b>5.</b> Page 14, line 24: after that line insert:
15	"SECTION 45m. Appropriation changes.
16	(1) Additional position. In the schedule under section $20.005$ (3) of the statutes
17	for the appropriation to the department of administration under section $20.475\ (1)$
18	(d) of the statutes, as affected by the acts of 1995, the dollar amount is increased by
19	\$48,800 for fiscal year 1995–96 and the dollar amount is increased by \$48,800 for
20	fiscal year 1996–97 to increase the authorized FTE positions for the department by
21	1.0 GPR position for an assistant district attorney for Milwaukee County.".
