



**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 303**

May 25, 1995 - Offered by COMMITTEE ON RURAL AFFAIRS.

1 **AN ACT** *to renumber and amend* 95.69 (1) (c); *to amend* 95.68 (2); and *to create*
2 95.68 (2m), 95.69 (1) (c) 3. and 95.69 (8m) of the statutes; **relating to:**
3 exempting certain auctioneers from the requirement to obtain a livestock
4 dealer license and exempting certain persons from the requirement to obtain
5 a livestock market license.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 **SECTION 1.** 95.68 (2) of the statutes is amended to read:

7 95.68 (2) LICENSE. ~~No~~ Except as provided in sub. (2m), no person may operate
8 a livestock market without an annual license from the department. A livestock
9 market license expires on June 30 annually. A separate license is required for every
10 livestock market. A license is not transferable between persons or locations.

11 **SECTION 2.** 95.68 (2m) of the statutes is created to read:

12 95.68 (2m) EXCEPTION. A person is not required to obtain a license under sub.
13 (2) to operate an occasional auction sale sponsored by a livestock breeder association

1 if records of the transactions at the sale are maintained by an auctioneer registered
2 under ch. 480 or by a livestock dealer licensed under s. 95.69.

3 **SECTION 3.** 95.69 (1) (c) of the statutes is renumbered 95.69 (1) (c) (intro.) and
4 amended to read:

5 95.69 (1) (c) (intro.) "Livestock dealer" means a person who, as principal or
6 agent, engages in the business of buying for resale or for slaughter, selling or
7 exchanging livestock. "Livestock dealer" does not include a any of the following:

8 1. A livestock dealer employe or the.

9 2. The operator of a farm who sells livestock if the operator keeps them on the
10 farm solely for dairy, breeding or feeding purposes and the operator is not otherwise
11 engaged in the business of buying them for resale, slaughter, sale or exchange.

12 **SECTION 4.** 95.69 (1) (c) 3. of the statutes is created to read:

13 95.69 (1) (c) 3. An auctioneer registered under ch. 480 who conducts any of the
14 following:

15 a. A farm sale at which no livestock is sold on a consignment basis.

16 b. A sale conducted at a state, county or district fair or a breeder association
17 show.

18 **SECTION 5.** 95.69 (8m) of the statutes is created to read:

19 95.69 (8m) TRANSACTION RECORDS. An auctioneer registered under ch. 480 who
20 sells livestock and who is not required to obtain a license under this section shall
21 make records of the sales available to the department upon request for disease
22 investigation purposes.
