



**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 325**

September 14, 1995 - Offered by COMMITTEE ON INSURANCE, SECURITIES AND
CORPORATE POLICY.

1 **AN ACT** *to renumber and amend* 655.005 (2); *to amend* 180.1901 (1m) (b) and
2 448.08 (4); and *to create* 180.1901 (1m) (am), 180.1901 (1m) (bg), 180.1901 (1m)
3 (br), 180.1901 (1m) (g) and 655.005 (2) (b) of the statutes; **relating to:** health
4 care professional service corporations.

*The people of the state of Wisconsin, represented in senate and assembly, do
enact as follows:*

5 **SECTION 1.** 180.1901 (1m) (am) of the statutes is created to read:

6 180.1901 (**1m**) (am) Chiropractic examining board under ch. 446.

7 **SECTION 2.** 180.1901 (1m) (b) of the statutes is amended to read:

8 180.1901 (**1m**) (b) Medical examining board under subch. II of ch. 448.

9 **SECTION 3.** 180.1901 (1m) (bg) of the statutes is created to read:

10 180.1901 (**1m**) (bg) Physical therapists affiliated credentialing board under
11 subch. III of ch. 448.

12 **SECTION 4.** 180.1901 (1m) (br) of the statutes is created to read:

13 180.1901 (**1m**) (br) Dietitians affiliated credentialing board under subch. IV of
14 ch. 448. This paragraph does not apply after June 30, 1999.

1 **SECTION 5.** 180.1901 (1m) (g) of the statutes is created to read:

2 180.1901 (**1m**) (g) Hearing and speech examining board under subch. II of ch.
3 459.

4 **SECTION 6.** 448.08 (4) of the statutes is amended to read:

5 448.08 (4) PROFESSIONAL PARTNERSHIPS AND CORPORATIONS PERMITTED.

6 Notwithstanding any other provision in this section, it is lawful for 2 or more
7 physicians or 2 or more podiatrists, who have entered into a bona fide partnership
8 for the practice of medicine or podiatry, to render a single bill for such services in the
9 name of such partnership; and it also is lawful for a service corporation to render a
10 single bill for services in the name of the corporation; provided that each individual
11 physician or podiatrist that renders billed services and each individual licensed,
12 registered or certified under subch. III or IV of this chapter or ch. 446, 449, 450, 455
13 or, 457 or 459 that renders billed services is individually identified as having
14 rendered such services.

15 **SECTION 7.** 655.005 (2) of the statutes is renumbered 655.005 (2) (intro.) and
16 amended to read:

17 655.005 (2) (intro.) The fund shall provide coverage, under s. 655.27, for claims
18 against the health care provider or the employe of the health care provider due to the
19 acts or omissions of the employe acting within the scope of his or her employment and
20 providing health care services. This subsection does not apply to ~~an employe~~ any of
21 the following:

22 (a) An employe of a health care provider if the employe is a physician or a nurse
23 anesthetist or is a health care practitioner who is not providing health care services
24 under the direction and supervision of a physician or nurse anesthetist.

25 **SECTION 8.** 655.005 (2) (b) of the statutes is created to read:
