ASSEMBLY AMENDMENT 37, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO 1995 ASSEMBLY BILL 557

October 5, 1995 - Offered by Representatives PLOMBON and KAUFERT.

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 31, line 3: after that line insert:
3	"SECTION 62m. 85.20 (4m) (a) of the statutes is amended to read:
4	85.20 (4m) (a) From the amounts appropriated under s. 20.395 (1) (bq), except
5	as provided in par. (ar), an amount equal to 42% of the projected operating expenses
6	of each eligible applicant's urban mass transit system shall be allocated to each
7	eligible applicant.
8	SECTION 64m. 85.20 (4m) (ar) of the statutes is created to read:
9	85.20 (4m) (ar) The department shall make supplemental payments of state
10	aid from the appropriation under s. 20.395 (1) (bq) to each applicant within an urban
11	area having a population as shown in the 1990 federal decennial census of at least
12	50,000 and meeting the federal definition of urbanized area for the purpose of federal
13	mass transit aid. Notwithstanding pars. (a) and (em) 1., the sum of the state aid
14	allocations made to an applicant under this paragraph and par. (a) may exceed the
15	percentage of projected operating expenses specified in pars. (a) and (em) 1.,

proportionately distributed to each eligible applicant, as determined by the
 department.

2. From the appropriation under s. 20.395 (1) (bq), the department shall
allocate \$237,600 in fiscal year 1995–96 and \$962,400 in fiscal year 1996–97 for the
purpose of making supplemental payments of state aid under subd. 1.

6 SECTION 66m. 85.20 (4m) (em) 1. of the statutes is amended to read:

85.20 (4m) (em) 1. An Except as provided in par. (ar), an amount equal to 42%
of the audited operating expenses for the project year of the applicant's urban mass
transit system.".

10 **2.** Page 88, line 21: after that line insert:

"(9tx) MASS TRANSIT OPERATING ASSISTANCE. The treatment of section 85.20 (4m)
(a), (ar) and (em) 1. of the statutes first applies to state mass transit operating
assistance payments for calendar year 1996.".

14 **3.** Page 90, line 3: after that line insert:

15 "(10tx) MASS TRANSIT OPERATING ASSISTANCE. The treatment of section 85.20
16 (4m) (a), (ar) and (em) 1. of the statutes takes effect on January 1, 1996.".
