



**SENATE AMENDMENT 12,
TO 1995 SENATE BILL 144**

September 27, 1995 - Offered by Senator ZIEN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 8: after that line insert:

3 “(as) If a sheriff has in his or her possession a firearm that has been surrendered
4 under par. (a) 2., the sheriff shall ensure that the firearm is properly maintained by
5 a person competent to perform the maintenance work. For purposes of this
6 paragraph, proper maintenance includes all of the following:

7 1. The cleaning and oiling of the firearm at least once every 60 days.

8 2. If the firearm is antique or rare or is otherwise similar to a museum object,
9 the cleaning, treatment and other work necessary to preserve the firearm’s finish,
10 artwork and detailing.

11 3. If the firearm is in a leather or wood case, the cleaning, treatment and other
12 work, done with the proper materials, necessary to maintain the case.

13 (at) A sheriff to whom a firearm has been surrendered under par. (a) 2. is liable
14 for any damage caused to that firearm, or any case in which the firearm is encased,
15 while it is in the possession of the sheriff.”

16 **2.** Page 9, line 22: after that line insert:

1 “(as) If a sheriff has in his or her possession a firearm that has been surrendered
2 under par. (a) 2., the sheriff shall ensure that the firearm is properly maintained by
3 a person competent to perform the maintenance work. For purposes of this
4 paragraph, proper maintenance includes all of the following:

5 1. The cleaning and oiling of the firearm at least once every 60 days.

6 2. If the firearm is antique or rare or is otherwise similar to a museum object,
7 the cleaning, treatment and other work necessary to preserve the firearm’s finish,
8 artwork and detailing.

9 3. If the firearm is in a leather or wood case, the cleaning, treatment and other
10 work, done with the proper materials, necessary to maintain the case.

11 (at) A sheriff to whom a firearm has been surrendered under par. (a) 2. is liable

14 **3.** Page 11, line 8: after that line insert:

15 “(as) If a sheriff has in his or her possession a firearm that has been surrendered
16 under par. (a) 2., the sheriff shall ensure that the firearm is properly maintained by
17 a person competent to perform the maintenance work. For purposes of this
18 paragraph, proper maintenance includes all of the following:

19 1. The cleaning and oiling of the firearm at least once every 60 days.

20 2. If the firearm is antique or rare or is otherwise similar to a museum object,
21 the cleaning, treatment and other work necessary to preserve the firearm’s finish,
22 artwork and detailing.

23 3. If the firearm is in a leather or wood case, the cleaning, treatment and other
24 work, done with the proper materials, necessary to maintain the case.

1 (at) A sheriff to whom a firearm has been surrendered under par. (a) 2. is liable
2 for any damage caused to that firearm, or any case in which the firearm is encased,
3 while it is in the possession of the sheriff.”
