



**SENATE AMENDMENT 6,
TO 1995 SENATE BILL 144**

September 27, 1995 - Offered by Senator ZIEN.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 1: delete "Require" and substitute "Except as provided in par.
3 (ak), require".

4 **2.** Page 8, line 8: after that line insert:

5 "(ak) As an alternative to surrendering a firearm under par. (a) 2., the
6 respondent may elect to sell or make a gift of any firearm that he or she owns to
7 another person. The respondent must make an election under this paragraph by
8 informing the judge or family court commissioner no later than 24 hours after the
9 injunction under sub. (4) is issued that he or she is selling or making a gift of some
10 or all of the firearms he or she owns. Upon being informed by the respondent that
11 he or she is electing to sell or make gifts of firearms under this paragraph, the judge
12 or family court commissioner shall stay the surrender requirement under par. (a) 2.,
13 except that any firearms that the respondent elects not to sell or give away shall be
14 surrendered as provided under par. (a) 2. A judge or family court commissioner may
15 issue any necessary additional orders concerning the procedure for selling or making
16 a gift of a firearm under this paragraph."

1 **3.** Page 9, line 15: delete “Require” and substitute “Except as provided in par.
2 (ak), require”.

3 **4.** Page 9, line 22: after that line insert:

4 “(ak) As an alternative to surrendering a firearm under par. (a) 2., the
5 respondent may elect to sell or make a gift of any firearm that he or she owns to
6 another person. The respondent must make an election under this paragraph by
7 informing the judge or court commissioner no later than 24 hours after the injunction
8 under sub. (5) is issued that he or she is selling or making a gift of some or all of the
9 firearms he or she owns. Upon being informed by the respondent that he or she is
10 electing to sell or make gifts of firearms under this paragraph, the judge or court
11 commissioner shall stay the surrender requirement under par. (a) 2., except that any
12 firearms that the respondent elects not to sell or give away shall be surrendered as
13 provided under par. (a) 2. A judge or court commissioner may issue any necessary
14 additional orders concerning the procedure for selling or making a gift of a firearm
15 under this paragraph.”.

16 **5.** Page 11, line 1: delete “Require” and substitute “Except as provided in par.
17 (ak), require”.

18 **6.** Page 11, line 8: after that line insert:

19 “(ak) As an alternative to surrendering a firearm under par. (a) 2., the
20 respondent may elect to sell or make a gift of any firearm that he or she owns to
21 another person. The respondent must make an election under this paragraph by
22 informing the judge or court commissioner no later than 24 hours after the injunction
23 under sub. (4) is issued that he or she is selling or making a gift of some or all of the
24 firearms he or she owns. Upon being informed by the respondent that he or she is

1 electing to sell or make gifts of firearms under this paragraph, the judge or court
2 commissioner shall stay the surrender requirement under par. (a) 2., except that any
3 firearms that the respondent elects not to sell or give away shall be surrendered as
4 provided under par. (a) 2. A judge or court commissioner may issue any necessary
5 additional orders concerning the procedure for selling or making a gift of a firearm
6 under this paragraph.”.
