3	involving recklessness".
4	2. Page 2, line 5: after that line insert:
5	"SECTION 1m. 895.52 (3) (intro.) of the statutes is amended to read:
6	895.52 (3) LIABILITY; STATE PROPERTY. (intro.) Subsection (2) does not limit the
7	liability of an officer, employe or agent of this state or of any of its agencies for either
8	any of the following:".
9	3. Page 2, line 13: after that line insert:
10	"SECTION 2g. 895.52 (3) (c) of the statutes is created to read:
11	895.52 (3) (c) A death or injury which occurs on property designated by the
12	department of natural resources under s. 23.115 or designated by another state
13	agency for a recreational activity if the officer, employe or agent who caused the death
14	or injury intentionally did an act, or intentionally failed to do an act that is his or her
15	duty to another to do, knowing or having reason to know of facts which would lead
16	a reasonable person to realize not only that his or her conduct creates an

6	this state or any of its agencies or of an officer, employe or agent of such a

9	"SECTION 3m. 895.52 (4) (c) of the statutes is created to read:
10	895.52 (3) (c) A death or injury if the officer, employe or agent who caused the
11	death or injury intentionally did an act, or intentionally failed to do an act that is his
12	or her duty to another to do, knowing or having reason to know of facts which would
13	lead a reasonable person to realize not only that his or her conduct creates an
14	unreasonable risk of physical harm to another but also that that risk is substantially
15	greater than that which is necessary to make his or her conduct negligent.".
16	5. Page 3, line 3: after "agents" insert: "for a death or injury if the officer,
17	employe or agent who caused the death or injury intentionally did an act, or
18	intentionally failed to do an act that is his or her duty to another to do, knowing or
19	having reason to know of facts which would lead a reasonable person to realize not
20	only that his or her conduct creates an unreasonable risk of physical harm to another
21	but also that that risk is substantially greater than that which is necessary to make
22	<u>his or her conduct negligent or</u> ".
23	6. Page 3, line 21: after that line insert:

24 **"SECTION 6m.** 895.52 (6) (cm) of the statutes is created to read:

1 895.52 (6) (cm) The private property owner or his or her employe or agent who 2 caused the death or injury intentionally did an act, or intentionally failed to do an 3 act that is his or her duty to another to do, knowing or having reason to know of facts 4 which would lead a reasonable person to realize not only that his or her conduct 5 creates an unreasonable risk of physical harm to another but also that that risk is 6 substantially greater than that which is necessary to make his or her conduct 7 negligent.".
