The person or agency that provides the education program shall report to the agency primarily responsible for

- providing services to the child expectant mother about the child expectant mother's attendance at the program.".

- (b) If the report prepared under s. 48.33 (1) recommends that an adult expectant mother is in need of education relating to the use of cigarettes or tobacco products, the court may order the adult expectant mother to participate in a cigarette or tobacco product education program approved by the court. The person or agency that provides the education program shall report to the agency primarily responsible for providing services to the adult expectant mother about the adult expectant mother's attendance at the program.".
