## ASSEMBLY SUBSTITUTE AMENDMENT 2, TO 1997 ASSEMBLY BILL 63

May 1, 1997 - Offered by Representative Schneider.

AN ACT *to create* 20.485 (2) (dk), 20.485 (2) (e), 45.03 (2m) and 45.035 of the statutes; **relating to:** Korean War memorials at The Highground and at Plover and making appropriations.

## Analysis by the Legislative Reference Bureau

Under current law, money has been provided to construct 3 memorials at The Highground in Clark County: one for the veterans of World War I, one for the veterans of World War II and one for the veterans of the Persian Gulf War. This bill appropriates \$80,000 for the construction of a memorial at The Highground in Clark County for the veterans of the Korean War. The bill also appropriates \$90,000 for the perpetual care of the Korean War memorial located at Plover in Portage County.
