ASSEMBLY AMENDMENT 10, TO ASSEMBLY SUBSTITUTE AMENDMENT 1, TO 1999 ASSEMBLY BILL 312

October 28, 1999 – Offered by Representative BOCK.

1	At the locations indicated, amend the substitute amendment as follows:
2	1. Page 4, line 6: delete lines 6 to 20 and substitute:
3	"SECTION 11f. 48.375 (4) (a) 1. of the statutes is renumbered 48.375 (4) (a) 1.
4	(intro.) and amended to read:
5	48.375 (4) (a) 1. (intro.) The person or the person's agent has, either directly
6	or through a referring physician or his or her agent, received and made part of the
7	minor's medical record, under the requirements of s. 253.10, the voluntary and
8	informed written consent of the minor and the voluntary and informed written
9	consent of one of her <u>the minor's</u> parents <u>who has legal custody of the minor;</u> or of the
10	minor's guardian or legal custodian, if one has been appointed; or of an adult family
11	member of the minor; or of one of the minor's foster parents or treatment foster
12	parents, if the minor has been placed in a foster home or treatment foster home and

1	the minor's parent has signed a waiver granting the department, a county
2	department, the foster parent or the treatment foster parent the authority to consent
3	to medical services or treatment on behalf of the minor. <u>All of the following shall</u>
4	govern the provision of consent under this subdivision by the parent, guardian, legal
5	custodian, foster parent or treatment foster parent:".
6	${f 2.}$ Page 4, line 22: delete "or legal custodian" and substitute ", legal custodian,
7	foster parent or treatment foster parent".
8	${f 3.}$ Page 5, line 2: delete "or legal custodian" and substitute ", legal custodian,
9	foster parent or treatment foster parent".
10	4. Page 5, line 3: delete "or legal" and substitute ", legal".
11	5. Page 5, line 4: delete "custodian" and substitute "custodian, foster parent
12	or treatment foster parent".
13	6. Page 6, line 10: delete lines 10 to 22 and substitute:
14	"SECTION 17f. 48.375 (4) (b) 3. of the statutes is amended to read:
15	48.375 (4) (b) 3. The minor provides the person who intends to perform or
16	induce the abortion with a written statement, signed and dated by the minor, that
17	a parent who has legal custody of the minor, or the minor's guardian or legal
18	custodian, if one has been appointed, or an adult family member of the minor, or a
19	foster parent or treatment foster parent, if the minor has been placed in a foster home
20	or treatment foster home and the minor's parent has signed a waiver granting the
21	department, a county department, the foster parent or the treatment foster parent
22	the authority to consent to medical services or treatment on behalf of the minor, has
23	inflicted abuse on the minor. The person who intends to perform or induce the
24	abortion shall place the statement in the minor's medical record. The person who

intends to perform or induce the abortion shall report the abuse as required under
s. 48.981 (2).".

5	"SECTION 24f. 48.375 (7) (f) of the statutes is amended to read:
6	48.375 (7) (f) Certain persons barred from proceedings. No parent, or guardian
7	or legal custodian, if one has been appointed, or foster parent or treatment foster
8	parent, if the minor has been placed in a foster home or treatment foster home and
9	the minor's parent has signed a waiver granting the department, a county
10	department, the foster parent or the treatment foster parent the authority to consent
11	to medical services or treatment on behalf of the minor, or adult family member, of
12	any minor who is seeking a court determination under this subsection may attend,
13	intervene or give evidence in any proceeding under this subsection.".
14	9. Page 15, line 25: delete that line.
15	10. Page 16, line 1: delete lines 1 to 9 and substitute:
16	"SECTION 39f. 809.105 (13) of the statutes is amended to read:
17	809.105 (13) CERTAIN PERSONS BARRED FROM PROCEEDINGS. No parent, or
18	guardian or legal custodian, if one has been appointed, or foster parent or treatment
19	foster parent, if the minor has been placed in a foster home or treatment foster home,
20	and the minor's parent has signed a waiver granting the department of health and
21	family services, a county department under s. 46.215, 46.22 or 46.23, the foster
22	parent or the treatment foster parent the authority to consent to medical services or
23	treatment on behalf of the minor, or adult family member, as defined in s. 48.375 (2)

(b), of any minor who has initiated an appeal under this section may attend or
intervene in any proceeding under this section.".
