## ASSEMBLY AMENDMENT 3, TO 2001 ASSEMBLY BILL 555

October 16, 2001 – Offered by Representatives MEYERHOFER, LASSA, MILLER and KRUG.

At the locations indicated, amend the bill as follows: 1  $\mathbf{2}$ **1.** Page 3, line 8: after that line insert: "(bm) 1. No credit may be claimed under this subsection unless the claimant 3 employs at least 3 journeymen for every 2 apprentices the claimant employs, except 4  $\mathbf{5}$ that, if the claimant employs only one apprentice, the claimant shall employ at least 6 one journeyman. 7 2. No claimant may claim a credit under this subsection for wages paid to an apprentice if another claimant claims a credit under this subsection for wages paid 8 9 to the same apprentice. 10 3. Monthly, each claimant who intends to claim a credit under this subsection 11 shall submit its payroll records to the department on a date and in a manner 12prescribed by the department. The claimant shall certify to the department, in a 13manner prescribed by the department, that its records are accurate and that it has

complied with subds. 1. and 2. The department shall review the records to verify that 1  $\mathbf{2}$ the claimant has complied with subds. 1. and 2. If the claimant has not complied with 3 subds. 1. and 2., the department of workforce development shall notify the 4 department of revenue of such noncompliance.".

**2.** Page 6, line 3: after that line insert:

6 "(bm) 1. No credit may be claimed under this subsection unless the claimant employs at least 3 journeymen for every 2 apprentices the claimant employs, except 7 8 that, if the claimant employs only one apprentice, the claimant shall employ at least 9 one journeyman.

2. No claimant may claim a credit under this subsection for wages paid to an apprentice if another claimant claims a credit under this subsection for wages paid 11 12to the same apprentice.

133. Monthly, each claimant who intends to claim a credit under this subsection shall submit its payroll records to the department on a date and in a manner 1415prescribed by the department. The claimant shall certify to the department, in a manner prescribed by the department, that its records are accurate and that it has 1617complied with subds. 1. and 2. The department shall review the records to verify that the claimant has complied with subds. 1. and 2. If the claimant has not complied with 18 19 subds. 1. and 2., the department of workforce development shall notify the 20department of revenue of such noncompliance.".

**3.** Page 8, line 14: after that line insert:

22"(bm) 1. No credit may be claimed under this subsection unless the claimant 23employs at least 3 journeymen for every 2 apprentices the claimant employs, except that, if the claimant employs only one apprentice, the claimant shall employ at least
 one journeyman.

2. No claimant may claim a credit under this subsection for wages paid to an
apprentice if another claimant claims a credit under this subsection for wages paid
to the same apprentice.

6 3. Monthly, each claimant who intends to claim a credit under this subsection 7 shall submit its payroll records to the department on a date and in a manner 8 prescribed by the department. The claimant shall certify to the department, in a 9 manner prescribed by the department, that its records are accurate and that it has 10 complied with subds. 1. and 2. The department shall review the records to verify that 11 the claimant has complied with subds. 1. and 2. If the claimant has not complied with 12subds. 1. and 2., the department of workforce development shall notify the 13department of revenue of such noncompliance.".
